York Region is currently undertaking a comprehensive study of its future water and wastewater rates beyond 2021. Staff agreed to report back on how much of the Region's 9% 2020 rate increase is attributed to the City of Toronto increasing their costs to York Region.

Committee briefly discussed York Region's year over year increases to the water and wastewater rate and the impact it has on residents.
