## **Community Flag-raising and Flag Protocol Policy**

- Claudia Storto, City Solicitor & Director of H.R. is attending today's meeting to discuss and hear feedback on the flag raising at the City of Markham. The community flagpole flag raising is to celebrate diversity and inclusion and flags are raised based upon requests from within the community and for dedicated use by the community. The City of Markham does not endorse or support any flag. There is a policy on requests and a process that accompanies that. City staff has been asked to do due diligence on the process and whether the City should continue to take a neutral stance. The process, criteria and decisions need to be transparent and accessible to everyone in the community. Claudia will share the feedback from the RRC to the group reporting on the flag raising protocols.
- It has been noted that one section of the Community Flag Raising Criteria is vague and confusing. The criteria should be in accordance with the principles enshrined in the Canadian Charter of Rights and Freedoms. This is an ongoing discussion that will continue via email and will be on next month's RRC meeting agenda under Race Relations Business.

# Motion to recommend Markham City Council update the Community Flag Raising Criteria with the following wording:

In accordance with the principles enshrined in the Canadian Charter of Rights and Freedoms, Community Flagpoles will not be used to fly flags—

- i) of Political Parties;
- ii) of Religious Groups;
- iii) in support of fund-raising drives that are political or religious in nature; and
- iv) in support of groups, organizations, or events that incite and promote hatred, violence and/or other forms of discrimination

### **Quebec's Bill 21**

 Committee members discussed whether the objection to Quebec's Bill 21 should be described as "oppose" or "condemn". The consensus conclusion is that "condemn" is more appropriate.

Motion: "Be it resolved that the Race Relations Committee recommends that Markham City Council condemn Quebec's Bill 21 in support of building a welcoming city where everyone has access to opportunity and prosperity. Moreover, that residents and those who visit are free from discrimination on the basis of race, sexual orientation, gender, and specifically religious practice."
