Deputation Statement in Support of Open skating and enjoyment of Milne Pond and the Markham Green Pond (for Town Council Meeting February 23, 2021)

To Markham Council,

This deputation is in full support of the Change.org petition relating to the use of ponds in Markham. I move that the City stop the use of by-law officers, police and security guards to prevent residents from skating and using the ponds at Milne and Markham Green (near Legacy).

The tax-paying residents should be able to use these areas, free from interference since there are several benefits:

- Improved physical and mental health of residents especially important during the pandemic which restricts what residents can do to stay active
- Improved quality of life and desirability of Markham as a destination for residents and businesses
- Use of the ponds provides ample capacity which allows for safe social distancing and takes the pressure off local rinks such as Legacy Public School (leaving it available and safer for local and younger skaters)
- Skating and hockey are woven into the very fabric of Canadian Society and a national pastime

Instead of preventing residents from enjoying use of these lands, I suggest the Mayor and Council should be looking for ways to support this desire of the tax-payers. This could be achieved by:

- 1) Immediately stopping bylaw officers, police and security guards from preventing residents from using these ponds
- 2) Further communicating to residents that use of the ponds is at their own risk and the City does not maintain them (these signs seem to be in place already)
- 3) Engaging the current residents who are already measuring the thickness of the ice, clearing the rinks and maintaining them. Encourage open communication as to the ice thickness. Consider using existing communication channels to communicate any changes of open/closed. Longer term, perhaps we could use a simple red/green flag system
- 4) Council should consider redeploying existing arena and other staff to help support the outdoor rinks on

ponds. Be creative to find ways to do this within existing budgets and staffing levels to support residents

By next winter, Markham Council should create and implement plans for the City to support skating in Rouge Park on Milne Pond and Markham Green Pond. This would be a great way to improve activity and enjoyment of the land for residents during winters for generations to come. It is also a great way to honour and celebrate the rich history of the area – Milne Dam and the heritage of the area with its rich history dating back to the very founding of Markham. What a great legacy for Mayor and Council to leave to future generations.

Many other municipalities are actively encouraging residents to use their waterways and ponds for skating – high profile examples include Ottawa on the Rideau Canal and nearby Uxbridge.

Please consider this input and work with your residents to increase the enjoyment and health of our Markham community.
