

### **Integrity Commissioner Recruitment Comparisons**

Legislative Services staff undertook a survey of other municipalities in August of 2020 and again in April of 2021 to inquire how their IC services were retained.

Highlights of the most recent survey include:

- 5/11 are or will be using RFP for the selection of their IC (Oakville Oshawa, Mississauga, Georgina, Markham);
- Oshawa has delegated authority to appoint the IC and piggy backed on Durham Region's contract. They will use RFP next time;
- 4/11 use a recruitment process (East Gwillimbury, Aurora, Richmond Hill, Vaughan);
- 2/11 use a selection process (Ottawa, King) which involves advertising for the position and conducting interviews and are appointed on Clerk/CAO recommendation;
- Ottawa's selection process is overseen by the Clerk, Deputy Clerk and Auditor General
