I am writing to request that you strongly support the motion in relation to the alignment of the Yonge North Subway Extension contained in item 9.3 of the Agenda for the Development Services Committee meeting on June 7, 2021.

I have followed this issue closely since the Option 3 re-routing was first introduced by Metrolinx a few months ago. Surprisingly, it was simultaneously identified as the preferred route and, in fact, the only option currently under consideration. One would have thought that such a significant change to long established plans for a Yonge Street alignment would have been accompanied by thorough research and analysis that would make it plain to all that Option 3 is clearly a better idea.

Unfortunately, Metrolinx has fallen way short of providing a convincing business case for Option 3. In various virtual town halls and Council meetings, solid answers to very legitimate questions have not been forthcoming. A common explanation for their vague or non-responses has been that they are only at the very early stages of their initial business case analysis. This answer alone demonstrates Metrolinx's lack of good faith and, as such, their assertions and recommendations cannot be relied upon. Essentially, the message from Metrolinx is, "We've identified the best solution, and now we're working very hard to understand the problem."

Perhaps the most blatant example of light-weight planning is when asked what the impact of the sacrifice of 2,000 Langstaff power corridor parking spaces under Option 3 would be on local traffic, subway access and greenhouse gas emissions, Metrolinx admitted that they hadn't considered this and would have to look at it.

Please say NO to ill-though-out Option 3 by saying YES to the motion in agenda item 9.3.

RE: Yonge North Subway Extension Alignment

I fully support the extension of the subway into York Region but am strongly opposed to Option 3. Option 3 will tunnel under an existing, well established neighborhood that we have been a part of for more than 30 years. Two other options as proposed in the Metrolinx Business Case would keep the subway extension under Yonge Street, without interfering with people in their current homes and meets the goal of sound practices in transit planning.

Until March 2021, no one in this community was aware that the subway extension plans had changed from the original subway extension proposal in 2009. We were shocked when we were told by Metrolinx that a new preferred route was decided upon, without any consultation with the community. The Metrolinx "preferred option 3" would mean tunneling under existing homes without any guarantees that sound and vibrations would be zero. It has been stated multiple times by Metrolinx, that they would do what they could to *limit* the amount of noise and vibration. Once a subway is built, if there is sound and vibrations felt, there is no solution. It is too late.

Transit is built for communities. A community should be served by transit and our community should benefit from the subway extension north. How could the Metrolinx preferred route Option 3 tunnelling beneath homes without knowing **if it will impact** the homeowners, with no guarantee for easy access to a subway stop and with two stations built within 400m of each other be acceptable to anyone? Eliminate High Tech Station, build the Bridge Station underground and ensure that the neighborhoods north of Steeles are served well by the subway extension, with stations that support their neighborhoods along the subway route. Metrolinx should be supporting getting people out of cars and onto transit. This cannot be accomplished with supporting Option 3. Option 3 is designed for one future community of condos, instead of communities of many.

Metrolinx insists on referring to their engagement with the community as consultative. They have in no way consulted with this community. They have TOLD the community what they are doing, asked for questions but don't answer them, do not reply in a timely way, and have not provided examples or information from any other transit project that would help to alleviate any concerns of this community.

In fact, they can't, because this project is unprecedented. We are confident that noise and vibrations will be felt in this community and homes will be expropriated for the project and in the end we will still not have access to a subway station without driving to it. This is not transit friendly planning, it is not smart planning or beneficial to existing neighborhoods north of Steeles.

Phil Verster of Metrolinx has said that funding for any of the options is not the issue, and he has also said that Options 1 and 2 are not "off the table" for discussion, as they are very appropriate choices. As Councillors for the City of Markham, and as a resident of Markham, I request that you do the right thing for your current constituents and reject Option 3.
