SUBJECT: Award of Construction Tender 042-T-21 Erosion Restoration at

Rouge River and Tributary to German Mills Creek

RECOMMENDATION:

1) That the report entitled "Award of Construction Tender 042-T-21 Erosion Restoration at Rouge River and Tributary to German Mills Creek" be received; and,

- 2) That the contract for Tender 042-T-21 Erosion Restoration at Rouge River and Tributary to German Mills Creek be awarded to the second lowest priced Bidder, Hawkins Contracting Services Ltd. in the amount of \$403,251.88, inclusive of HST impact; and,
- That a 10% contingency in the amount of \$40,325.19 inclusive of HST, be established to cover any additional construction costs and that authorization to approve expending of this contingency amount up to the specified limit be in accordance with the Expenditure Control Policy; and,
- 4) That the construction award in the amount of \$443,577.07 (\$403,251.88 + \$40,325.19) be funded from 750-101-5699-21157 "Erosion Restoration Program"; and
- 5) That the remaining funds in project #21157 "Erosion Restoration Program" in the amount \$74,302.93 be retained in the account for other immediate restoration work that may be required in 2021-2022.
- 6) That Staff be authorized and directed to do all things necessary to give effect to this resolution.

PURPOSE:

The purpose of this report is to obtain Council approval to award the contract erosion restoration at Rouge River and the Tributary to German Mills Creek, at the locations shown in Attachment 'A' and 'B'.

BACKGROUND:

In 2019, through the City erosion inspection process, staff discovered significant movement of the watercourse had occurred that was threatening the City owned trail at the Rouge River, and City owned sanitary sewer network at the Tributary to German Mills Creek.

The work consists of the following:

• Mobilization and site preparation, including fencing, traffic/pedestrian control, access route protection, signage;

- Environmental protection works, including tree protection, site dewatering, and erosion and sediment control;
- Erosion restoration works, including grading, boulder placement, and City sanitary sewer encasement;
- Cleanup and restoration of the work area upon completion of the works;

Timing of this work is subject to environmental timing windows subject to TRCA regulations, and as such, work on the Rouge River site must be completed between July 1 and September 15, and work on the Tributary to German Mills Creek must be completed between July 1 and March 31.

Staff will notify the public of this project by posting signage at the sites prior to construction being initiated, mailing out notices to residential properties in the vicinity of the project, and through the City's social media.

Staff recommend not awarding the Contract to the lowest priced bidder on the basis that reference checks did not provide proof of their experience. Pursuant to Part II Section 17.4 of the City of Markham's General Terms and Conditions (which form part of the tender document), the City reserves the right, in its sole discretion, not to award to the lowest priced Bidder, whose reference checks do not meet or exceed the expectations of the City.

The 2nd low bidder (Hawkins Contracting) has related experience and have good performance history with the City.
