



## BY-LAW 2021-XX

### A By-law to amend By-Law No. 2012-137, being a by-law to impose fees or charges for licences and permits issued by the City of Markham

**WHEREAS** Subsection 391(a) of the Municipal Act, 2001. S.O. 2002.C.25 as amended authorizes municipalities to pass by-laws imposing fees or charges on any class or persons for services or activities provided or done by or on behalf of it;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM ENACTS AS FOLLOWS:**

- (1) That the Licensing, Permit and Service Fees By-law # 2012-137 Section 1 be amended as follows:
  - A) Add a definition for Private Transportation Company (PTC) to read;
 

*“means any Person who facilitates or operates a Ride-Sharing Service through a Platform”*
  
- (2) That the Licensing, Permit and Service Fees By-law # 2012-137, Schedule “A” be amended as follows:
  - A) That a “Licence Type” be added for “Private Transportation Companies”
  - B) That the following sections be added:
