5.0 GENERAL MANAGER'S REPORT

- Theatre remains shut down
- Working on Capital Projects
- Fire Alarm Upgrades
- Upcoming HVAC project to start in May to be completed in August.
- Working on a plan to reopen

6.0 PRIORITY ITEMS:

6.1 Theatre reopening

- Reports state consumers will be looking to be back once we get past pandemic
- Theatre
- plan for 50% in late fall, 75% by Q2 2022, 100% January 2023
- Reopening scenario
- Continue and grow streaming and virtual programs (Q1)
- Non-public rentals Spring / Summer (Q2)
- Summer camps hybrid indoor/outdoor/virtual (Q3)
- Public in person w/limited capacity (Q4)
- Increased capacity 2022 50%-75% (2022)
- Full Capacity (2023)

Opening sequence:

- May August: Soft reopening, virtual programs in house, youth camps, fundraising, summer outdoor facility, partial staff return
- Sept Dec: Open public rentals, fundraising, virtual, soft reopening, more staff return.
- Jan 2022: All programs, all staff return

Costs

- Using the cost recovery model rentals can be sustainable this Spring/Summer
- In the spring/summer utilize PT staff as bringing back FT staff might be a challenge
- With grants camps could break even

6.2 Fundraising

- Reopening will required up to an additional \$300K to have staff back in place and programs back in 2022
- Various possible source of funding:
 - City funds
 - Sponsors
 - grants Canadian Heritage
 - Use of Theatre endowment
 - Other FR sources tbd
- Discussion on City support for the reopening costs

7.0 WORKING COMMITTEES AND TASK FORCES

Fundraising -

• Best is to start to look at this soon, and develop a strategy and a plan

- FR \$150K from sponsors should be a doable ask
- There are some companies doing very well and they may be able to give, others are closing. We need to identify the companies that are doing well and see if maybe we can find new sponsors
- Fundraising will not be easy but reaching out might be fruitful
- We are still waiting on the City paperwork for us becoming a foundation that would certainly help with fundraising
