Financially, we are breaking even on the Market. We have a surplus funds for upcoming events in the Fall and Winter if needed. Niina asked Board members to submit or bring forward any ideas they may have on spending the surplus before the end of the year.

We are looking at an office space on the second floor of the McKay Art Centre, it is temporarily closed right now but opening soon. It is difficult for members to find our office in the basement, and it is an uncomfortable and dark location to work. The rent at McKay is \$400-\$500 a month. Our lease at 157 Main street is up in July,2022. We can start looking for a new space so that when the lease is up we can plan on moving the UBIA office. If anyone hears of space please let Sara know.

City Update by Councillor Reid McAlpine

Niina, Sara and Reid met with the City at the Vasilovskys to see if there is a way for the City to help with repair and repaving, and new marketings in the East parking lot. The City has replied that they do not have funds allocated to this, this year. They will do the repairs but not more. This should be revisited after street redevelopment in 2023.

ED Report: By Sara Sterling

Crosby: The City has put flowers and a bench to block the second side of the Crosby driveway, it looks great.

Market: Unionville Market is coming along really well, averaging 500-600 visitors per weekend.

Music: Music is played every Saturday and Sunday on the street and has received a lot of positive feedback. Partnership with MAC working well.

ByLaws: The Bandstand and ByLaws in general continue to be a big issue. Both Sara and Reid have tried to get action on this but no luck so far. They will continue to push and are arranging a meeting with the City Clerk and ByLaw Director soon. Tony wants to push for more regulations on AFrames, others are not bothered by A Frames.

Fall and winter events: We will be moving ahead with ladies night in October, barring a Fourth Wave that would stop us. Christmas plans are unknown right now but we are hoping to have an afternoon full of activities and parade on Saturday the 4th.

Selfie Walls: The Autumn Selfie Walls will be installed soon, mid-September.

RFP

Kash, Sylvia, Nilna, Reid and Don are part of the RFP Committee. They met and reviewed the responses, but not all read the responses and others on the Board had no opinion on the matter. Niina does not want to make the decision on her own and suggested a month extension to September 15th so others can contribute to the conversation, as this is a \$40,000 budget item. UPDATE: Another meeting of the subcommittee was held and a new Government program has been announced that might dovetail into
