

Planning to reconstruct Main Street in Unionville has been underway for several years. The Unionville Villagers Association has been consulted throughout the process. This street is a major tourist attraction in City of Markham and York Region, helping to draw more than 1,000,000 visitors annually to the City. This jewel deserves to be presented in the best light. In addition to making Main Street Unionville a beautiful place for residents and business owners, adopting Treatment 3A which replaces asphalt with interlocking brick pavers will support local tourist attractions on and beyond Main Street. Varley Art Gallery, local hotels, local restaurants, and other small businesses in City of Markham will benefit from all efforts to increase the foot traffic coming to Markham.
