Main Street Unionville Streetscape Revitalization UBIA Deputation February 22, 2022

Good morning Mr. Mayor, Councillors, and Staff

My name is Niina Felushko and I am the Chair of the Unionville Business Improvement Area. I am here today to support Staff recommendation #3A in the Revitalization of Main Street Unionville. As the Chair of the Board, I speak on behalf of our 10 Board members and 60 member businesses.

Unionville has long been recognized by many as The Tourism Core of York Region. As such, it should feature beautiful and pedestrian-friendly streets with shaded sidewalks, heritage-style functioning lamp posts and well-taken care of heritage buildings. Currently this is not the case, with crumbling streets and sidewalks, lamp posts that will not light up with decades-old wiring, and a general lack of vision with landscaping and heritage feeling.

We understand that the landlords and business owners on Main Street need to do their part in this Revitalization, and have been encouraging them as such. In 2021, we promoted the City's Commercial Façade Improvement Program and had more applications than ever submitted, resulting in a more than doubling of the Program for 2022. We also consistently push our businesses to weed their properties, fix chipped paint and repair or replace unlawful signage. Two of the major vacant spaces on the street that are in disrepair have now been leased and will be undergoing major improvements in the next 6 months.

We have also implemented and initiated many programs to increase the odds of success for our businesses. We wrote and put out an RFP for a Retail Action Plan that included in-depth market research and retail consulting with the ultimate goal of creating the most appealing retail mix possible on Main Street. Shortly thereafter, the Economic Development Council of Ontario announced the My Main Street Local Business Accelerator program, which we applied for and were successful with a \$50,000 grant towards hiring a Business Advisor that will conduct work very similar to what was in our RFP. We have hired an experienced local Business Development executive to do market research, provide business advice in many forms, and assist businesses in applying for \$10,000 grants that also came with the program.

As we could not host our regular events during the pandemic, we invested heavily in our streetscape décor with new holiday lighting that has attracted thousands of tourists to the area over the winter months. We have been very proactive with our social media and marketing, with contests and consistent recognition in province-wide publications as a "must see" destination.

The UBIA strongly feels that Option #3A will do the right job of highlighting this amazing destination. The brick pavers along the entire street, sidewalks and boulevards will encourage even more pedestrian activity, which is what brings in the revenue to our businesses and

maintains the sense of community we offer. Main Street should not be seen as a quick thoroughfare to use instead of Kennedy Road, it should be seen as a spot where you walk first, drive second.

Option #4 is not the right solution as we feel the stone paver "breaks" along the street will only further confuse pedestrians as to where they can and cannot cross the street. The stone pavers also offer no warmth in terms of look and feel, while brick pavers are more closely connected to a Heritage design.

Option #3A will strengthen Main Street's "sense of place" and bring nothing but success and recognition to MARKHAM, not just Unionville. It will continue to hold its standing as a unique heritage district where people want to dine, shop and meet with friends and family, all year long.
