York Region Environmental Alliance (YREA) strongly supports the motion by RC Jim Jones that Markham object to the GTA West/Hwy 413. YREA previously wrote <u>letters of concern</u> to municipalities in York Region regarding the contentious GTA West/Hwy 413. Dear Councillors,

We are both writing to urge you to withdraw Markham's support for the construction of Highway 413, as motioned by Regional Councillor Jones and Councillor Usman. Environmentally, highway 403 is unsound, paving over forests, wetlands, farmlands and part of the greenbelt. This highway would run in a similar direction, just a few kilometres north, of the underutilized highway 407.
