Business Arising from the Minutes</p>	<p>Committee reviewed the list of action items and updated the Action Item Table (view last page of the Minutes document for details).</p> <ul style="list-style-type: none"> - <u>Pet Licensing Renewal Form outstanding revisions:</u> June Ziola reported that she had reviewed the Pet Licensing Renewal Form and observed: <ul style="list-style-type: none"> - the Sample Form on the website is the 2012 version and it would take a lot to change it on the website; - the changes requested by the Committee have been made to the actual Pet Licensing Renewal Form; however, the donation section still reads “Animal Care 	<p>Christy Lehman will advise the Tax Department that this should be corrected.</p>																				

	<p>Committee” whereas it should read “Markham Animal Care Services”.</p> <ul style="list-style-type: none"> - that there may still be confusion regarding payment methods - during the online renewal process, there is a notice that one would receive the tags within 5-7 days, but tags are no longer used <p>- <u>Coyote Response Report Update from November 29, 2021 General Committee</u> Christy Lehman advised that, following a lengthy discussion, the Markham Animal Care Services report was approved with few changes. It has been published on the City’s website and officers are using it in the course of their duties. Markham will host a virtual public education session on this topic on March 23, 2022 @ 7:30 pm. Markham is also planning to develop educational pieces for schools.</p> <p>Responding to questions about possible plans for guidelines for destruction of coyotes, Christy confirmed that Markham has the authority to kill a coyote but only does so as a last resort in extreme circumstances, since this does not solve the problem. Markham practices a human coexistence strategy with wildlife but this means residents must not feed coyotes.</p> <p><u>2022 Proclamations</u> Christy Lehman advised that all proclamations were approved by Council. A further report will be discussed at the next meeting.</p>	<p>Christy Lehman will have the website form and process updated.</p> <p>Vikrum Pain will provide a report at the February meeting.</p>
<p>6. Animal Services Program Update</p>	<ul style="list-style-type: none"> - <u>Cat Adoption & Education Centre (CAEC)</u> Christy Lehman advised that the CAEC is closed at this time. - <u>Shades of Hope Wildlife Centre (SOH)</u> Christy advised that SOH attended the November 29, 2021 General Committee meeting in support of the staff report and the coyote coexistence plan. Christy further advised that the Committee will be welcome to tour the SOH facilities when health 	

	<p>guidelines permit. It was also suggested that a tour of the CAEC be arranged for Committee members.</p>

New Business	<ul style="list-style-type: none"> - <u>Emergency Preparedness for Pets and Educating residents about keeping cats and wildlife safe</u> Valerie Burke put forward these ideas for the Committee to consider, possibly as part of the Committee’s Annual Plan. - <u>Roadmap for the New Year/Annual Plan</u> For the benefit of new members, Areez Remtulla reviewed the Committee Terms of Reference (TOR), noting that it is a valuable guiding reference. The TOR require the Committee to develop an Annual Plan. <p>Christy Lehman suggested that the Animal Care Services department would welcome help from the Committee to educate Markham residents about the human coexistence strategy with wildlife. It was suggested that Committee members be sent the TOR, a previous business plan, and a previous PowerPoint presentation, to use as references to form ideas for the 2022 Annual Plan.</p> <p>Quiddie Chung and Dr. Esther Attard joined the meeting at 6:30 pm.</p> <p>Dr. Esther Attard spoke about her role in animal care services for the City of Toronto and provided insight into the decision-making process for the recent shooting of a coyote in Toronto. Dr. Attard reported that Toronto is, and Christy Lehman advised that Markham has started, reaching out to the Indigenous community to help educate residents about coexistence; it was agreed to include this outreach in the Annual Plan.</p>	<p>Staff was asked to follow up on the status of a Committee motion requesting General Committee to ask staff to update bird-friendly guidelines to CSA standards.</p> <p>Janet Andrews will send Committee members the TOR, a previous business plan, and a PowerPoint presentation to use as references.</p>
