1. CALL TO ORDER

The Markham Environmental Advisory Committee (MEAC) was called to order at 7:05 PM with Stuart Cumner presiding as Chair.

2. CHANGES OR ADDITIONS TO THE AGENDA

The agenda was accepted as distributed.

3. ADOPTION OF THE MINUTES OF THE MARKHAM ENVIRONMENTAL ADVISORY COMMITTEE MEETINGS HELD ON NOVEMBER 25, 2021 AND ON JANUARY 27, 2022

4. MATTERS ARISING FROM THE MINUTES

Regional Councillor Joe Li advised that a proposal regarding the installation of infrastructure for an underground waste management system for new developments of 500 units or more will be implemented in the new Markham Centre development (Highway 7 and Warden Avenue) and also in a Langstaff development; it is hoped these projects will now be fast-tracked. On behalf of MEAC, Chair Stuart Cumner congratulated Regional Councillor Joe Li on the progress of the proposal.

5. MEAC FOCUS FOR 2021

On behalf of Vice Chair Andrew Hazen, Chair Stuart Cumner reported regarding the "Get Your Lawn Off Gas!" project that:

- Andrew has met with the Sustainability Manager of Home Depot to discuss discounts for residents who turn in their gas mower in favour of buying an electric or humanpowered model; he is waiting for feedback
- A communication professonal has been engaged to advise the York University C4 students on promotional strategy and content
- MEAC and the C4 students will need to liaise with Markham Corporate Communications to have materials approved
- MEAC will need to review funding options.

In response to questions about printing capacity, it was recommended that, due to Covid concerns, MEAC consider virtual options including portable signage at major Markham intersections.

MEAC members were reminded that they will need to embrace the project and assume responsibility for it at the end of the C4 students' academic year.

The Committee discussed a number of marketing strategies including a public awareness/educational campaign, coupons for new homeowners, investigating ideas used by other municipalities, allowing residents to "test drive" electric/human-powered equipment, and getting Eco Clubs at schools involved. It was agreed to invite the communication professional, advising the C4 students on marketing strategies, to the next MEAC meeting.

6. NEW BUSINESS

A. Friends of Swan Lake Park

At the January 2022 MEAC meeting, Fred Peters, a resident of the Swan Lake community in Markham, presented "A Holistic Approach To Realizing Community Goals For Restoration of Swan Lake and Swan Lake Park". He advised that the Friends of Swan Lake Park are advocating for Markham to:

- 1. Adopt a "holistic" Eco Park approach that recognizes "Restoration" of Swan Lake and Swan Lake Park as a critical community need.
- 2. Establish a "Mesotrophic" state as an "aspirational" long-term water quality goal.
- 3. Approve a Pathway to Sustainability long-term sustainable solutions that restore aquatic and terrestrial environment.
- 4. Implement a Stewardship Plan that integrates all departmental elements and existing policies.

That the Markham Environmental Advisory Committee (MEAC) endorse in principle and refer to Markham Council for consideration:

- (a) the Swan Lake "Restoration" Objective;
- (b) an Eco Approach that integrates community objectives with restoration processes; and
- (c) the establishment of a Stewardship Plan to include an environmental monitoring framework

B. Earth Month Planning

Jennifer Wong reported that the Earth Day event would focus on the pilot, *Power.House Hybrid: Minimizing GHGs Emissions and Maximizing Grid Benefits*, a study evaluating how ten Markham homes might generate and store clean energy, and optimize electrical and thermal technologies, to minimize greenhouse gas (GHG) emissions. A Question and Answer session hosted by local youth leaders would feature the City of Markham and its partners Alectra Utilities, Enbridge Gas, Ryerson University, and Natural Resources Canada. Both a media event and community event are planned; although a date has not yet been finalized for

the community event, it is expected that it will be scheduled for an evening in the week leading up to Earth Day April 22, 2022.

Gabriela Ansari-Correa advised that "Get Your Lawn Off Gas!" project would be a good fit to be included in the Sustainability Office's Earth Month plans for a "30 Days/30 Posts" campaign.

7. OTHER BUSINESS

- <u>Ban on Single Use Plastics</u> Vicki Choy advised that the Canadian Federation of University Women (CFUW) Markham/Unionville gratefully received a letter from Mayor Frank Scarpitti in response to the CFUW letter requesting that Markham take immediate action to implement the ban on single use plastics.
- <u>Shift: Action for Pension Wealth and Planet Health</u> is a charitable initiative that works to protect pensions and the climate by bringing together beneficiaries and their pension funds on the climate crisis. A representative will attend the next meeting of MEAC.
- Resignation Chair Stuart Cumner advised that Victoria Genge had resigned from the Committer. On behalf of MEAC, he thanked her for efforts and wished her well in her future endeavours.
- New Members Laura Gold, Council and Committee Coordinator, Clerk's Department, has advised that there are three vacant positions on the Committee. It was advised that Markham is currently advertising for volunteers to sit on Advisory Committees. Chair Stuart Cumner will consult with Ms. Gold about the recruiting process.
