Discussion

- As of May 9, 2022, Members of Council have the option to attend Council, Standing Committee, or Statutory Public meetings in-person (in the Chamber) or remotely (via Zoom).
- Prior to making this option available, the Council Chamber was deep-cleaned and the HVAC system was upgraded to improve health and safety.
- From an operational perspective, staff are able to support in-person, full capacity attendance in the Council Chamber for the public for the May 26th meeting should Council decide to proceed with this option.
- One of the implications of allowing in-person public attendance for the May 26th meeting is that it may become an expectation that all future Council, Standing Committee and Statutory Public meetings will also allow in-person public attendance.

Discussion (Cont'd)

If members of the public are permitted to attend the May 26th meeting inperson, staff will undertake the following at minimal additional cost:

- Communicate the attendance options available for the meeting using the City's various communication channels;
- Enhance the cleaning and sanitization protocol for the Great Hall and Council Chamber leading up to and following the May 26th meeting;
- Open the Great Hall entrance to the public 30 minutes prior to the meeting;
- Post 2 additional Security Guards in the Great Hall area to assist with customer service, access and ensure general safety and security;
- Enable use of the accessible public washrooms in the lower atrium; and,
- Position hand sanitizing stations at the entrance to the Chamber.
