A By-law to amend By-law 1229, 11-72, 122-72, 134-79, 304-87, and 177-96, as amended

The Council of The Corporation of the City of Markham hereby enacts as follows:

- 1. That By-law 1229, as amended, is hereby further amended as follows:
 - 1.1 By deleting Schedule 'B' SPECIAL POLICY AREA to By-law 1229, as amended by by-law 162-90 and 2006-154;
 - 1.2 By adding a new Schedule 'B' SPECIAL POLICY AREA to By-law 1229, attached as Schedule 'A' to this By-law;
 - 1.3 All other provisions of By-law 1229, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
- 2. That By-law 11-72, as amended, is hereby further amended as it applies to the lands outlined on Schedule 'A' as follows:
 - 2.1 By deleting Schedule 'C' SPECIAL POLICY AREA to By-law 11-72, as amended by by-law 203-92 and 2006-151;
 - 2.2 By adding a new Schedule 'C' SPECIAL POLICY AREA to By-law 11-72, attached as Schedule 'A' to this By-law;
 - 2.3 All other provisions of By-law 11-72, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
- 3. That By-law 122-72, as amended, is hereby further amended as it applies to the lands outlined on Schedule 'A' as follows:
 - 3.1 By deleting Schedule 'B' SPECIAL POLICY AREA to By-law 122-72, as amended by by-law 163-90 and 2006-150
 - 3.2 By adding a new Schedule 'B' SPECIAL POLICY AREA to By-law 122-72, attached as Schedule 'A' to this By-law
 - 3.3 All other provisions of By-law 122-72, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
- 4. That By-law 134-79, as amended, is hereby further amended as it applies to the lands outlined on Schedule 'A' as follows:
 - 4.1 By deleting Schedule 'B' SPECIAL POLICY AREA to By-law 134-79, as amended by by-law 164-90 and 2006-152
 - 4.2 By adding a new Schedule 'B' SPECIAL POLICY AREA to By-law 134-79, attached as Schedule 'A' to this By-law
 - 4.3 All other provisions of By-law 134-79, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
- 5. That By-law 304-87, as amended, is hereby further amended as it applies to the lands outlined on Schedule 'A' as follows:
 - 5.1 By deleting Schedule 'B' SPECIAL POLICY AREA to By-law 304-87, as amended by By-law 165-90 and 2006-153

 - 6.2 All other provisions of By-law 177-96, as amended, not inconsistent with the provisions of this by-law shall continue to apply.

BY-LAW 2022-

A By-law to amend By-law 1229, 11-72, 122-72, 134-79, 304-87, and 177-96, as amended

UNIONVILLE SPECIAL POLICY AREA BOUNDARY UPDATE

Background

The City of Markham has one Special Policy Area in Unionville to manage historic development within the flood plain of the Rouge River and its tributaries. The Unionville Special Policy Area was established in 1990 through Official Plan Amendment No. 100 to the 1976 Official Plan and implemented through by-laws 162-90, 163-90, 164-90, 165-90 and 203-92. The Unionville Special Policy Area boundary was updated in 2006 through by-laws 2006-150, 2006-151, 2006-152, 2006-253, 2006-154 and 2006-155. This amendment will update the Special Policy Area boundary to reflect flood plain changes identified by the TRCA in 2019.

Lands Affected


The proposed by-law amendment applies to lands within the flood plain of the Rouge River and its tributaries generally bounded by Birchmount Ave to the west, Highway 407 to the south, Carlton Road to the north and McCowan Road to the east.

Purpose and Effect

The purpose and effect of this By-law is to delete the current Special Policy Area schedules and to replace it with a new schedule to show the updated Special Policy Area boundary.

Note Regarding Further Planning Applications on this Property

The *Planning Act* provides that no person shall apply for a minor variance from the provisions of this by-law before the second anniversary of the day on which the by-law was amended, unless the Council has declared by resolution that such an application is permitted.
