1.0 GENERAL

- **1.1** PART I INTRODUCTION, is included for information purposes and is not an operative part of this Official Plan Amendment.
- **1.2** PART II THE OFFICIAL PLAN AMENDMENT, constitutes Official Plan Amendment No. XXX to the City of Markham Official Plan 2014, as amended. Part II is an operative part of this Official Plan Amendment.

2.0 LOCATION

This Amendment applies to 2.09 ha (5.14 ac) of land municipally known as 205 Torbay Road as shown on Figure 9.17.11 within the South Don Mills (Employment) district. The subject property is located west of the intersection of Torbay Road and Victoria Park Avenue. The subject property also includes portions of the Don Mills Channel and associated floodplain, which are protected by the existing 'Greenway' land use designation within the 2014 Markham Official Plan.

3.0 PURPOSE

The purpose of this Official Plan Amendment is to modify Section 9.17 to add a new site-specific policy to provide for a motor vehicle repair facility on the subject property.

4.0 BASIS OF THIS OFFICIAL PLAN AMENDMENT


This amendment will facilitate a motor vehicle repair facility use on the subject property designated 'General Employment' in the 2014 Markham Official Plan. The motor vehicle repair facility will provide a complimentary use to existing motor vehicle retail sales and service stations in the area

- **1.0** Section 9.17 of the Official Plan 2014, as amended, is hereby amended by:
 - a) Amending Section 9.17.1 to add a reference to a new Section 9.17.11 in Figure 9.17.1 as follows:

"9.17.11 <u>205 Torbay Road</u>


The following site specific use provisions shall apply to the 'General Employment' lands as shown as "A" in Figure 9.17.11:

- a) The following additional uses shall be permitted on the lands:
 - i. motor vehicle repair facility; and
 - ii. outdoor storage of motor vehicles.

b) The following uses shall not be permitted on the lands:

- i. the sale, leasing, or renting of motor vehicles;
- ii. outdoor storage, except as provided for in "a) ii." above; and

iii. outdoor repair or outside servicing of motor vehicles.



visions of the Official Plan, as amended, regarding the implementation and interpretation of the Plan, shall apply in regard to this Amendment, except as specifically provided for in this Amendment.

This Amendment shall be implemented by an amendment to the Zoning By-law and Site Plan approval and other *Planning Act* approvals, in conformity with the provisions of this Amendment.

This Amendment to the City of Markham Official Plan 2014, as amended, is exempt from approval by the Region of York. Following adoption of the Amendment, notice of Council's decision will be given in accordance with the Planning Act, and the decision of Council is final, if a notice of appeal is not received before or on the last day for filing an appeal.

Prior to Council's decision becoming final, this Amendment may be modified to incorporate technical amendments to the text and associated figure(s) and schedule(s). Technical amendments are those minor changes that do not affect the policy or intent of the Amendment. The notice provisions of Section 10.7.5 of the City of Markham Official Plan 2014, as amended, shall apply.
