Rentals are currently popular with other City departments who all want to have events on our site. Unfortunately, by the time we were allowed to open it was too late for the wedding season. We have had some interest from corporate rentals. Cynthia and all fulltime staff are back. Janet is back and the Research Facility has reopened. She is starting to plan our next exhibitions. Cathy took a moment to inform the Board of the passing of Paul Robertson, a friend and past President of the Ontario Museums Association.

The Chair gave a brief report. The Chair is glad to hear that all of the redeployed staff have returned to the Museum. She remarked that it was nice to be hearing mostly good news about the Museum lately, after the past two years.
