Re: 6.3 Demolition Permit - Intention to Demolish a Part-V Designated Property, 83 John Street, Thornhill

I am not in favour of the demolition of this 1946 one-storey DVA dwelling.

A review of The Thornhill-Markham Heritage Conservation District Inventory - 2007 indicates that 83 John Street is one of **only three** examples of a DVA house left in the Thornhill heritage district. There had to be more, obviously destroyed over the years to make way for much bigger, often over-sized homes. According to my internet research, DVA houses, although with issues like all homes, new or old, are considered to be better built than a lot of the homes built since.

Comments in the District inventory on 83 John Street:

"A close cousin to the Cape Cod cottage, but not so true to the original New England precedent style. *The small scale makes it fit in to the character of the village.*

Comments in the inventory regarding 183 John Street, although not indicated as a DVA house, say "The small scale prevents it from clashing with heritage buildings in the village." Would this not apply to 83 John Street as well?

Canada Post, in 1998, featured - and honoured - the humble "Veteran's House" on a stamp. The Canadian Government obviously regards these homes as a valuable, important part of our Canadian history.



Lot by lot, foot by foot, our Thornhill heritage district continues to lose ground -literally. If approval is given by Markham for this house to be demolished, Markham should stipulate that everything that can be salvaged from this house is salvaged.

I believe that 83 John Street could be incorporated as an important part of a larger new build ... that it would be an architect's dream to work their magic to include this special home and its history.
