



BY-LAW NUMBER 2023-76

TO AMEND BY-LAW 106-71

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM THAT BY-LAW NUMBER 106-71 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:

1. By adding to Schedule 12 – Compulsory Stops – at the following named intersections:

William Forster Road	Northbound on William Forster Road	South side of Riverlands Avenue, on the East side of William Forster Road

William Forster Road	Southbound on William Forster Road	North side of Rustle Woods Avenue, on the West side of William Forster Road
Honey Glen Avenue	Westbound on Honey Glen Avenue	East side of William Forster Road, on the North side of Honey Glen Avenue
Red Brick Road	Westbound on Red Brick Road	East side of William Forster Road, on the North side of Red Brick Road
Harvest Field Avenue	Westbound on Harvest Field Road	East side of William Forster Road, on the North side of Harvest Field Road
Harvest Field Avenue	Southbound on Harvest Field Road	North side of Red Brick Road, on the West side of Harvest Field Road
Riverland Avenue	Eastbound on Riverlands Avenue	West side of William Forster Road, on the South side of Riverlands Avenue

Riverland Avenue	Westbound on Riverlands Avenue	East side of William Forster Road, on the North side of Riverlands Avenue
Cumer Gate	Westbound on Cumer Gate	East side of William Forster Road, on the North side of Cumer Gate
Lane Z	Northbound on Lane Z	South side of Harvest Field Road, on the East side of Lane Z
Lane Z	Southbound on Lane Z	North side of Red Brick Road, on the West side of Lane Z
Lane Y1	Southbound on Lane Y1	North side of Harvest Field Road, on the West side of Lane Y1
Lane Y1	Northbound on Lane Y1	South side of Riverlands Avenue, on the East side of Lane Y1
Lane Y2	Westbound on Lane Y2	East side of Lane Y1, on the North side of Lane Y2
Lane Y2	Southbound on Lane Y2	North side of Harvest Field Road, on the West side of Lane Y2
Lane X2	Southbound on Lane X2	North side of Riverlands Avenue, on the West side of Lane X2

2. The By-Law shall come into force and effect upon receiving the third reading by the Council of the City of Markham and also when authorized signs have been erected.

Read and first, second and third time and passed on May 3, 2023.
