Hello, we are concerned residents of Duke of Cornwall Drive. We have received notification of a meeting on June 12 regarding the plan showing that Livante would like to build 168 stacked townhomes as well as a condo building. The original plan was for 20-25 single, detached dwellings and Livante has left this land empty for the last 10 years. It is an eyesore. The developer claimed that there was contamination on the land and they had to change their plans. We have seen no evidence of any effort on their part to clean the land in the meantime. We don't see a need for this much over development to make up for the fact that they have to fix the land before they can build. If the land is toxic, what is the city doing to ensure our safety?

There are concerns that these Townhomes would be directly behind us and infringe on our privacy. A large number of townhomes have already been built in our area. As a result, traffic has increased significantly with cars speeding through the development near the school, and the parks are very busy.

There is growing concern among residents about over development and news of a potential 8 storey condo also being built in the development is alarming given that this area was supposed to be low rise only.
