

Petition Against the Proposed Markville Secondary Plan

Dear Mayor, Councilors, and Staff,

We, the undersigned and concerned residents of Markham, write to express our strong opposition to the proposed development of 11-28 high-density commercial and residential buildings across 110 hectares of land in our Markville community. While we recognize the need for growth and development, we firmly believe that this plan will have a devastating impact on our city and the local residents. Therefore, we request that you reconsider and reject this proposed plan based on the following concerns:

Traffic and Overcrowding: The addition of 40,000 to 50,000 more residents will significantly jeopardize our already congested road infrastructure along McCowan Rd and Hwy 7. Increased traffic intersections and traffic lights will lead to longer traffic jams and more accidents on the roads.

Education Capacity: This Secondary Plan doesn't plan to build any new schools or daycare facilities. The influx of new residents will put a tremendous burden on our already struggling education system. For example, Markville Secondary School is already 30% above its designated capacity and will install six portable classrooms to accommodate the increased number of students. With 50,000 new residents, the existing school system will be highly over-capacitated if the governments don't have a prudent plan now.

Healthcare Capacity: Our local healthcare infrastructure is ill-equipped to handle an additional 40,000 to 50,000 residents. The proposed developments lack a plan for expanding healthcare facilities, which will result in longer clinic wait times, limited access to medical services, and a shortage of family doctors.

Lack of Parks and Community Centers: Our community has limited access to recreational areas and community centers. The proposed development fails to provide proper public recreational resources for the additional residents which will result in overcrowding of public parks.

The community consultation meetings that were held early this year haven't involved many of the local residents. We look forward to having more public consultation meetings which should be open, transparent, and extensive.
