**Property/Building Descriptions**: Abraham Reesor House, 1 ½ storey single detached dwelling

constructed c. 1875 and the Frank Albert Reesor House, 2

storey dwelling constructed c. 1922

Use: Residential

Heritage Status: Both Individually Designated under Part IV of the Ontario

Heritage Act

#### **Application Proposal**

• The City has received Major Heritage Permit applications for the siting, restoration and additions to both the Abraham and Frank Albert Reesor Homes which are to be relocated to lots within the planned residential development.

### **Background**

• In September of 2020, Heritage Markham supported the relocation of the Abraham and Frank Albert Reesor Homes to new lots shown in the Plan of Subdivision application SU 18 154617;

#### **Staff Comment**

- The restoration plans provided by the applicant are highly detailed and Heritage Section staff is satisfied that the homes have been thoughtfully sited with architecturally compatible additions that should make them highly desirable properties within the planned residential development of the land.
- Therefore, Heritage Staff recommends that the Heritage Markham supports both Major Heritage Permit applications and delegates final review of any application necessary to approve them to the City (Heritage Section) staff.

THAT Heritage Markham supports the Major Heritage Permit applications for the Abraham and Frank Albert Reesor and delegates final review of any application required for approval to the City, (Heritage Section) staff.











Appendix B- Location of New Lots for the Heritage Homes




North Elevation






East Elevation
