

TO AMEND BY-LAW 2018-130 BEING A BY-LAW AUTHORIZING DESIGNATED LANES IN THE CITY OF MARKHAM.

("Lane Designation By-law")

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM ENACTS AS FOLLOWS:

That the Lane Designation By-law 2018-130 be amended as follows:

1. That in Section 2, the following definitions be deleted and replaced as follows:

"bicycle" includes a tricycle, a unicycle and a power-assisted bicycle as defined under the *Highway Traffic Act*, but does not include a motor assisted bicycle as defined under the *Highway Traffic Act*;

"motor vehicle" includes an automobile, motorcycle, motor-assisted bicycle and any other vehicle propelled or driven otherwise than by muscular power, but does not include a power assisted bicycle as defined in the *Highway Traffic Act* or an electric kick-scooter; and

"vehicle" includes a motor vehicle, trailer, traction engine, farm tractor, roadbuilding machine, bicycle, electric kick-scooter, and any vehicle drawn, propelled or driven by any kind of power, including muscular power.

2. That in Section 2, the following definition be added:

"electric kick scooter" means a vehicle that meets the requirements set out in the *Highway Traffic Act* and Ontario Regulation 389/19, as amended, including that it has:

- (i) two wheels placed along the same longitudinal axis, one place at the front of the kick-scooter and one at the rear,
- (ii) a platform for standing between the two wheels,
- (iii) a steering handlebar that acts directly on the steerable wheel,
- (iv) an electric motor not exceeding 500 watts that provides a maximum speed of 24 kilometres per hour, and
- (v) a maximum weight of 45 kilograms (kg) and wheels with a diameter of not more than 430 millimetres (mm);

"motor assisted bicycle" means a bicycle as defined in the *Highway Traffic Act*, including,

- (i) that is fitted with pedals that are operable at all times to propel the bicycle,
- (ii) that weighs not more than fifty-five kilograms,
- (iii) that has no hand or foot operated clutch or gearbox driven by the motor and transferring power to the driven wheel,
- (iv) that has an attached motor driven by electricity or having a piston displacement of not more than fifty cubic centimetres, and
- (v) that does not have sufficient power to enable the bicycle to attain a speed greater than 50 kilometres per hour on level ground within a distance of 2 kilometres from a standing start;

"power-assisted bicycle" means a bicycle as defined in the *Highway Traffic Act*, including that it,

- (a) is a power-assisted bicycle as defined in subsection 2 (1) of the Motor Vehicle Safety Regulations made under the *Motor Vehicle Safety Act (Canada)*,
- (b) bears a label affixed by the manufacturer in compliance with the definition referred to in clause (a),
- (c) is fitted at all times with pedals that are operable to propel the bicycle, and
- (d) is capable at all times of being propelled on level ground solely by using muscular power to operate the pedals;
- 3. That Section 5 be deleted and replaced as follows:

The portion of the highway set out in Column 1 of Schedule "B" between the limits set out in Column 2 and the lane identified in Column 3 is hereby designated a bicycle lane for the exclusive use of bicycles and electric kick-scooters.

4. That Section 6 be deleted and replaced as follows:

No person shall operate a vehicle in a bicycle lane except for a bicycle or an electric kick- scooter.

5. That a new Schedule B be added as follows:
