I would like to express my strong opposition to the request for changing the zoning from Mixed Use Mid Rise to Residential High Rise. Approving this change sets a dangerous precedent that could pave the way for similar developments in the area and this proposal should be rejected. I have several significant concerns regarding this proposal. It is crucial to consider not only the impact of this single project but also the multiplier effect when other developers propose similar projects. The well-being of the area needs to be reviewed in conjunction with this one proposal.

1. Environmental Impact

a. Increased Pollution:

- High-rise buildings contribute to increased air and noise pollution both during and after construction. The construction process generates dust, emissions from construction vehicles, and noise pollution, all of which can negatively affect the health and well-being of local residents.

GoTrain is only useful for those working in downtown Toronto. Introducing high-rise buildings will only increase traffic congestion, noise, and air pollution.

3. Impact on Local Community

a. Community Character:

• High-rise buildings can drastically change the character of a neighborhood, overshadowing smaller buildings and altering the community feel. This can lead to a loss of the area's unique identity and charm. Additionally, high-rise buildings reduce sunlight for neighboring residents. If you spend much time in Toronto, you will notice that high-rise buildings have made the downtown area darker due to the shadowing from buildings, windier, and less aesthetically pleasing.
