

Christopher has been the executive Chef for the past eight years at one of the city's most busiest Mediterranean restaurants located at steels and Bathurst.

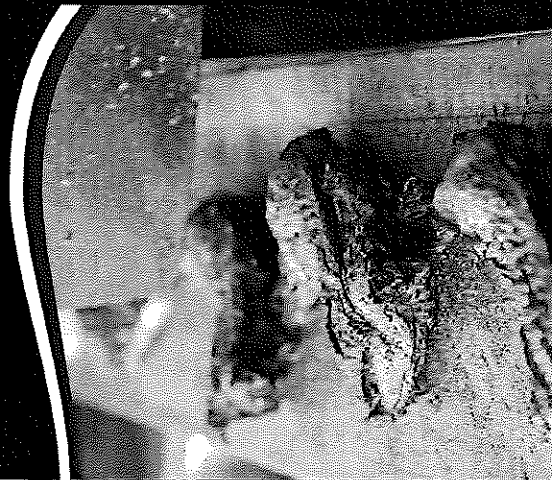
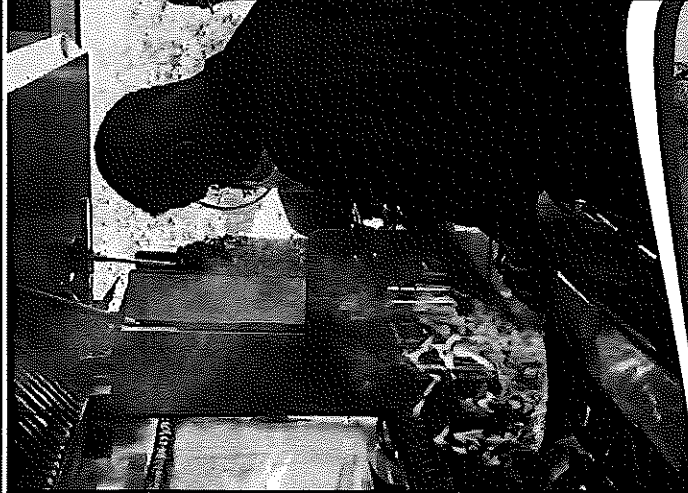
Well, after all these years, Christopher has finally returned to his first love... Caribbean food; To be particular, "YARD" aka Jamaican food.

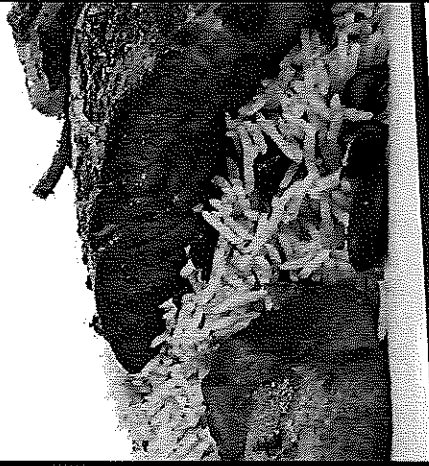

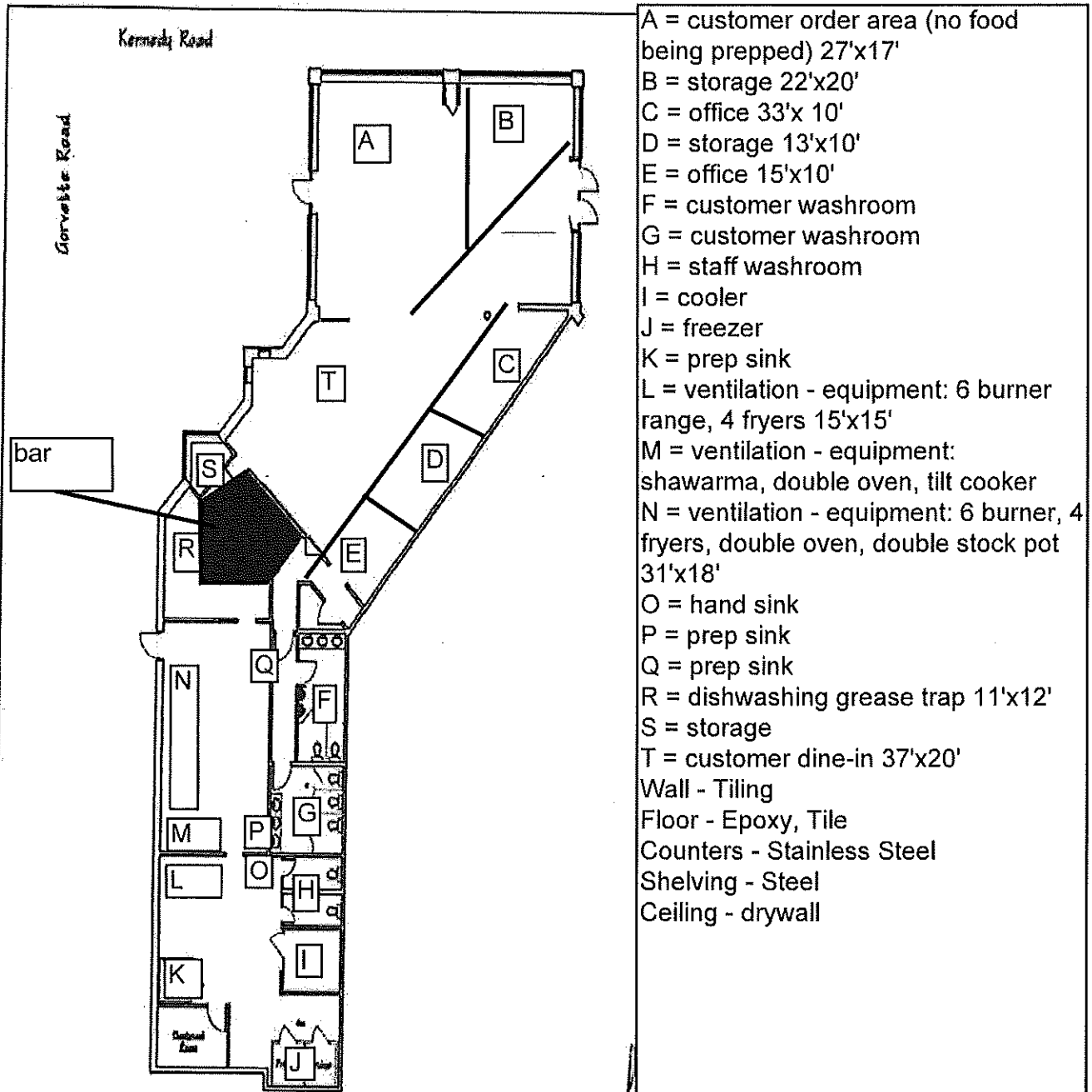
