### Re: Resolution Supporting FRW's Application to Canadian Federation of Municipalities

### **Dear Markham Mayor and Councillors:**

Thank you for supporting the community-based ecological restoration work of Friends of the Rouge Watershed (FRW) over the last three decades. In a past letter of support, Markham Mayor Frank Scarpitti noted:

"FRW has an excellent record of harnessing government, school, community and corporate support to achieve remarkable ecological restoration results."

Since 1993, with the help of Markham and many other partners, FRW has:

- Involved 73,258 school and community volunteers in ecological restoration work.
- Coordinated the planting and care of 799,118 native trees, shrubs, and flowers.
- Restored 3.6 square kilometres of forest, wetland, meadow, and stream buffer habitat.

This ecological restoration work yields public dividends of \$10+ Million every year, based on the 2009 Ontario Report "Estimating Ecosystem Services in Southern Ontario", and in terms of:

- Absorbing and storing carbon to combat extreme climate change and weather.
- Reducing flooding and erosion costs, through precipitation storage and recycling.
- Protecting human health by filtering-out air and water pollutants and producing oxygen.
- Enhancing urban green spaces for healthy outdoor recreation and relaxation.
- Improving ecosystem health, biodiversity, and habitat for species at risk.

To continue our forest and wetland restoration work in Markham, FRW is applying to the Canadian Federation of Municipalities (CFM) for \$90,000/year from 2025 to 2027 to help us:

- Educate and coordinate 6,000+ school, community, and corporate volunteers.
- Purchase, plant, water, protect and maintain 36,000+ native trees, shrubs & flowers.
- Restore 10+ hectares of diverse forest habitat on approved City of Markham greenspaces.

FRW respectfully requests a Markham Council motion to support our CFM application. We appreciate that Markham staff support FRW's application and have prepared a motion for your consideration in the format requested by CFM.

As climate change gathers steam, communities and infrastructure are increasingly vulnerable to costly damage from urban runoff and flash floods. In both 2013 and 2024, the GTA (Greater Toronto Area) suffered \$1+ Billion in damages from flooding.

In 2018, the Intact Centre on Climate Adaptation at the University of Waterloo, and Canada's Insurance Bureau, released the report "Combatting Canada's Rising Flood Costs" which notes:

- Economic losses quadrupled in Canada in nine years due to flooding and extreme weather.
- Forest & wetland restoration are among the most cost-effective ways to reduce flooding.
- Restoration projects are not being made at the scale and rate necessary.

After decades of scientific research and political debate, the United Nations (UN) declared 2021 to 2030 as the "Decade of Ecosystem Restoration". To reduce climate change, ecosystem decline and associated human suffering and economic losses, the UN has challenged everyone to help by planting one trillion trees worldwide in ten years.

In 2016, FRW received the J.R. Dymond Award from Ontario Nature for exceptional public service and environmental achievement. The award ceremony noted FRW's:
