Good evening and thanks for having me.

My name is Frederick Woo.

It is a deep regret that I being on the City list of notifications for years have not been notified of last Oct 28 Council special meeting if it is PUBLIC and tonight (Nov 4) public meeting,

Thanks to the Mayor announcement thru radio on last Oct 29 about the 3.88% property tax increase in 2025. And to Councillor Ritch Lau additional information on the tax increase vide his radio talk on Oct 30, 2024 at 12:30pm.

Thanks to Councillor McAlpine and Councillor Rea prompt reply email to me of last Oct 29, upon hearing the Mayor announcement on the 3.88% tax increase on last Oct 29, advising tonight public meeting,

1. City budget and tax increase in 2025:

Please find attached the emails between Mr. Joseph Silva, Treasurer of Markham, and me about the \$136M annual budget shortfall in 2023 that was not addressed in City budget in 2024 according to Mr. Silva. Understood from Mr. Silva email that the 136M shortfall is attributable to Bill 23.

Please advise if the \$136M has been addressed in City budget in 2025. If negative, please advise when it may be addressed referencing Bill 23. If Bill 23 is not modified to mitigate City budget and tax and to address the \$136M, among other issues, would the final 2025 property tax increase be way over the 3.88% or future years tax increases be significantly impacted.

Councillor Lau in his radio talk apparently advised the 3.88% tax increase in 2025 was City's portion. Should this be the case, would 2025 tax for York Region and School Board invite property tax increase say beyond 3.88% tax increase in 2025.

Councillor Lau apparently suggested there might be annual deficit for 2024. Would this impact property tax increase for 2024, 2025 etc.?

2. Infrastructure improvements on healthcare, schools, senior care, transportation etc. :

From the Mayor announcement in the radio talk on the 3.88% tax increase in 2025, sustainable infrastructure improvements to align with future developments and population growth were touched. In fact, the Mayor announcement echoes Federal Government recent announcement to cut

immigration for the next three years to address healthcare, housing et al. Understood that efforts of all levels of government are necessary. Please advise on the road map for the infrastructure improvements.

Good afternoon Mr. Woo.

Thank you for your message. I feel it is important to offer what will hopefully be further clarification on budget figures you note below. If easier, I can take a quick phone call to ensure I am being as clear as I can.

You note a \$5.7 million annual shortfall in 2024. Respectfully, I am not sure where this figure is coming from. What I can clarify, however, is that as part of Budget 2024 (e.g., Exhibit 1A in materials accessible via www.markam.ca/budget), we note a "net shortfall" in our Primary Operating Budget of \$5.27 million for 2024. Our discussion of "net shortfall" is our usual/standard approach to identify and quantify the proposed incremental levy requirement for the year. For 2024, this net shortfall is being addressed through the 2.99 per cent tax levy increase the City has adopted as part of Budget 2024.

The \$136 million potential impact speaks to an anticipated quantum resulting from Bill 23, should they all come to pass. As noted below, the Province is reviewing aspects of this legislation.
