Good evening.

I am Frederick Woo. Thanks for having me.

Infrastructure relates to healthcare, schools, senior care, transportation etc. to align with population growth and future developments of 44,000 residential units.

Thanks that the Mayor provided an insight at Council last Nov 4 meeting on City budget 2025 about plans for public transit improvements along existing highways and future major road works east to west. What about south to north? He also briefed on hospital expansion. I would like to respond to the Mayor input as follows.

Ward 3 Councillor newsletter of Dec 1, 2024 I have just received provides: "In Unionville Residents Association 2024 AGM, URA will be discussing the Hospital. Representatives of the Markham Stouffville Hospital have kindly agreed to present "The Future, Our Community, Our Hospital."

Much grateful that similar talks from Representatives of the Markham Stouffville Hospital would be held for residents in other Wards in Markham.

LOW CITY PARKING STANDARD for new condos, ie. around 0.5 parking per condo unit including for visitor along "major transit areas" imposed by the Province, as I was given to understand vs. around 1.15 parking per condo unit in the good old days. This relates to transportation.

Developer planning proposals have to be approved by the City. It is incumbent upon the City to see that the proposals are viable in the interest of the PEOPLE. Cases in point, would residents consider buying condo units without parking in major transit areas, on noting they might face problem to walk on icy sidewalks under snowy/windy weather to access to major public transit:

 a. to see doctors, or drug stores or for shopping, or go to hospital away from public transit. They may have to climb over snow banks at road curbs to access to VIVA,  some residents may be deterred to buy condo units without parking, as they may have concern on selling their units WITHOUT parking, or unless they buy these condo units for Airbnb.

The City may elect to leave this with developers. But what about the good old days in which the City has imposed much higher parking standard referred to for the sake of the PEOPLE. Credible developers understand this and will NOT follow low parking standard for their condo developments in major transit areas as evident in their current marketing of condo units. I understand it is a choice between two devils - provision of prudent parking as in good old days, or traffic jam until completion of pubic transit improvements and major road works east to west.

I am requesting a road map of the infrastructure improvements for the

communities that have raised concern on lack of sustainable infrastructures improvements before completion of future developments.
