7. PRESENTATIONS

7.1 2024 BILD BENCHMARKING STUDY (10.0)

Arvin Prasad, Commissioner, Development Services, provided opening remarks and introduced, Victoria Mortelliti and Alex Beheshti from the Building Industry and Land Development Association (BILD) who were in attendance to present the 3rd Edition Greater Toronto Area (BILD) Municipal Benchmarking Study that provided an overview of current municipal processes, issues and inefficiencies, approval timelines, charges and fees that impact the housing supply. It was highlighted that the City's overall rank increased to fifth among the 16 municipalities that participated in the study. Ms. Mortelliti thanked staff for their engagement in meaningful dialogue and indicated that she looks forward to a continued positive working relationship with the City.

Mr. Prasad acknowledged, John Yeh, Manager, Strategy and Innovation, Giulio Cescato, Director, Planning and Urban Design, Stephanie DiPerna, Director, Building Standards for their leadership across the commission that contributed to successful implementation of several process improvements.

The Committee thanked Ms. Mortelliti and Mr. Beheshti for the presentation and staff for their work on the improvements. There was discussion on the following in relation to the presentation:

- The time frame of when the data was collected;
- Whether the number of applications that were identified in the study also included the number of units proposed within the application;
- Whether there are other municipalities that accepted housing units in lieu of development charge fees;
- The impact on development applications and charges in municipalities with a two-tier government structures;
- The range in municipal fees and why the City's are higher in relation to other municipalities;

- Where there is not enough funding for growth to pay for growth, where does the shortfall come from; and,
- Whether there is a study to evaluate applications by region.

Staff indicated that the community benefits charge allows for the exchange of units or in-kind contributions and that it is charged at 4% of land value. Staff further indicated that the infrastructure needs and costs differ for each municipality and that in York Region there are longer distances to cover in the development of the required infrastructure which will impact the costs.

Arvin Prasad, Commissioner, Development Services, introduced the item and provided a timeline of events for this application. Mr. Prasad indicated that the owner is currently in a position to appeal their application.

Maria Gatzios, Gatzios Planning Consultants, was in attendance, virtually, and introduced, James Koutsovitis, who presented the previous and revised concept plans.

Councillor Rea, thanked staff and the applicant for the discussions to revise the designs and concepts.

The Committee requested clarification on the zoning criteria, height requirements, and the by-law for an alternative configuration.

Ms. Gatzios indicated that the applicant is not pursuing 10-storeys and that he won't be submitting a revised application for 10-stories and may exercise his appeal rights.

Claudia Storto, City Solicitor, advised that this is an application for a zoning bylaw amendment of the supported use and what Council prefers to see on the site and that this does not take away the applicants right of appeal.

Staff were requested to provide a memo at the December 18, 2024, Council Meeting with additional wording to support approval for 10 storeys and refusal for 13.

- 2. That staff bring forward an implementing By-law for a 10-storey mixed use building with a minimum Gross Floor Area (GFA) of 13,100 square metres and minimum non-residential GFA of 165 square metres on the lands municipally known as 5871 Highway 7, following review of revised plans to the satisfaction of the Director of Planning and Urban Design or his designate; and,
- 3. That Staff bring forward the amending Official Plan and Zoning By-law documents for Council approval to permit a 10-storey mixed use building on the lands municipally known as 5871 Highway 7, following review of revised plans to the satisfaction of the Director of Planning and Urban Design or his designate; and further,
- 4. That staff be authorized and directed to do all things necessary to give effect to this resolution.
