3)Increase the distance between the current homes on Waterloo Court and the Complex.4)Set out parameters to ensure that there is SAFETY(for Pedestrians,Cyclists,Deer etc), and minimal disturbance to Flora and Fauna during the multi-year construction of the Complex.

We earnestly hope the Council can catalyse such a dialogue between the community and the Baha'i Organization in a non-confrontational format prior to a final vote. This would result in a "Win -Win" for Markham!
