The Cycling & Pedestrian Advisory Committee (CPAC) convened at 7:04 PM on September 19, 2024, with Peter Miasek presiding as Chair.

7. STANDING ITEMS & ONGOING PROJECTS

- 7.1 City's Ongoing AT Project Updates
 - School Zone Safety Guide

Fion Ho, TDM Coordinator, Transportation advised that a virtual PIC was held on November 12, 2024, at 6:00 p.m. She further advised that the online survey will be available until November 30, 2024. For detailed information, please click on <u>School Zone Safety Guide</u>.

7.2 School Programs & Pilots

Reena Mistry, YRDSB provided an update on the School Programs and Pilots as follows:

- As she is going on leave, Katherine Shaw-Edmonds will fill in at CPAC meetings
- Year 2 of AST program at Beckett, Aldergrove and Parkland ESs is going well. Monthly events. Reeser Park ES also gets a half program
- Also supporting Markham District and Markville HSs
- A bike helmet giveaway would be a useful addition to the AST program, eg 20 helmets for Highgate ES to raffle off.

Cr. McAlpine advised that with respect to the purchase of helmets, school's do not have budget from a parent association, and schools from their grants are not funded for these activities and considering the demographics of where these schools are located, it is not realistic to ask parents to contribute 50% towards the purchase of helmets. He hoped that the year-end could possibly see local bike shops looking for ways to dispose off end of season inventory. He alluded to the Canadian Tire's Jump Start Program as an example where matching funds might exist. He suggested that Reena could provide CPAC with an estimate of what potential funding CPAC could consider for this activity.

Responding to a question from Peter Miasek, Chair of CPAC, Fion Ho, TDM Coordinator, Transportation advised that the Finance Department will need to be advised of the budget that CPAC intends to expend before the year end.

Loy Cheah, Senior Manager of Transportation Engineering advised that the budget for this year needs to be expended before the year end, and invoices need to be dated within this year.

Keenan Mosdell advised that Markham Cycles has a wholesaler that can assist in getting bike helmets at reasonable prices.

Action: Reena Mistry and Fion Ho to promptly work on purchasing bike helmets before the end of 2024 for gifting to Highgate Elementary School students.

- 7.3 <u>Reports to Council</u>
 - Fion Ho, TDM Coordinator, Transportation advised that a report on the Cycling Facility Selection Tool was considered by the Development Services Committee at its meeting on November 12, 2024, and recommendations from that meeting were approved by Council at its meeting on November 20, 2024. Loy Cheah, Senior Manager of Transportation Engineering advised that the Cycling Facility Selection Tool will be the City's policy in determining appropriate cycling facilities for AT projects to maintain city-wide consistency for these projects.
 - Fion Ho, TDM Coordinator, Transportation advised that a Council Workshop to develop the Vision Zero Road Safety Plan will be held at a Special Development Services Committee meeting at the Flato Markham Theatre on November 25, 2024. Responding to a question from Peter Miasek, Loy Cheah, Senior Manager of Transportation Engineering confirmed that this in-person meeting/workshop is open to the public, but because the workshop is dedicated to Members of Council, the public cannot participate in the discussion.
 - Loy Cheah also reported that a report was presented to Council November 20 on Bill212 and the effect on cycling projects in Markham

7.5 <u>Markham Cycling Day</u>

Fion Ho, TDM Coordinator, Transportation advised that Markham Cycling Day, the City's signature event was held on Sunday, June 9, 2024, at the Aviva Parking Lot, Markham Centre. The event was attended by 829 individuals. Due to rainy weather this year, the number of participants was lower than that in 2023. Fion illustrated a breakdown of participants: 540 for the Tour de Markham and 289 children ranging from age 3 to 10 for the race program. Rest Stops were provided at Milne Dam Park and Berczy Park North. All tour groups had 2-3 marshals and started from the main event site (Aviva Parking Lot). The event had to avoid Enterprise Boulevard due to current construction activity near the Pan Am Centre. The children's races, hosted by Station Ski & Ride Markham, started at 9:40 a.m. but had to end early due to the rainy weather closer to the middle of the day.

Fion Ho, TDM Coordinator, Transportation, thanked Cr. Ritch Lau for providing opening remarks, Operations and Events Teams, over 80 Volunteers and Marshals and the Markham Cycling Day Sub-committee members for supporting the 2024 Markham Cycling Day event.

Responding to a question from Anthony Ko about comparison with other city events, Fion advised that it is difficult to quantify the differences between events, because some events, e.g., Canada Day, are full-day events and have major sponsors contributing to such events, as well, such events sell spaces for vendors that are also sources of revenue for the events.

Amit Arora suggested organizing a mini-Markham cycling event for schools which could be a potential to encourage a younger age-group to get involved in cycling activities in the City. Responding to Amit's suggestion, Anthony Ko advised that Markham Cycles organizes such smaller-scale cycling events for kids which is becoming more popular every year.

Winter Pedestrian Subcommittee

Cr. Reid McAlpine advised that as part of the 2025 budget he suggested that the City consider paving the currently unpaved park trails that are not being plowed in the winter months in an effort to allow them to be plowed.

Loy Cheah, Senior Manager, Transportation Engineering advised that the Operations Department conducted a test of winter plowing operations and expressed difficulty in plowing gravel/unpaved pathways. Therefore paving is required.

Loy Cheah, Senior Manager, Transportation Engineering advised that sometime in 2018 staff tried to identify a trail network focussed around school zones that should be plowed to provide for year-round walking and cycling access for school students. This requires someone to plow within the school yard also. The ATMP has also identified and established a priority network for winter snow plowing activity that should be maintained year-round.

Reena Mistry advised that the YRDSB and the City have partnered on some trails and the Board is open to discussing more.

Peter Miasek suggested that a good first step would be to acquire a map of trail snow plowing activities conducted by the City. Loy Cheah, Senior Manager, Transportation Engineering advised that the City's winter snow plowing activities map is available on the City's Operations Department webpage: <u>www.markham.ca/neighbourhood-services/roads-</u> <u>sidewalks/winter-road-services</u>.

Innovation Subcommittee No update.

Bike Parking Subcommittee

Peter Miasek, Chair advised that:

- 1. The City conducted a study on different types of bike racks that are available in the market. Loy and Fion have agreed to source this document and provide it to CPAC.
- 2. Loy agreed that staff will conduct a survey to find out which City of Markham parks need additional bike racks, and this survey will be provided to CPAC sometime in 2025 for a recommendation to Council on next steps.
- 3. The subcttee has done preliminary thinking on a bike parking business partnership, eg at a mall. This idea is mentioned in the ATMP and has been nominated in the consultation for the Citywide Parking Strategy project.

7.9 Markham Cycles/CICS

Kevin Lee, Program Manager-Youth Services, provided a brief overview of CICS, a non-profit organization in Canada that provides support and resources for newcomers, immigrants, and various communities, particularly those facing social, economic, and cultural barriers. Established in 1968, CICS primarily serves the Greater Toronto Area, including York Region, Markham, Scarborough, and surrounding areas

with Settlement Services, Language Training, Employment Support, Youth Programs, Family and Community Programs & Cultural and Social Events.

Markham Cycles(MC) is a division of CICS. It has two community bike hubs located at Milliken Mills and Centennial Community Centre. Kevin advised that MC was previously operated by The Centre for Active Transportation (TCAT) and subsequently transitioned to CICS in 2024. CICS has maintained the same programming and services offered in previous years to support community engagement and active transportation. Keenan Mosdell has been retained as the Project Coordinator to ensure a smooth transition and continuity in program leadership. MC receives some funding support from the City of Markham and York Region.

Keenan Mosdell, Project Coordinator, MC provided a brief overview of the 2024 Programming. A do-it-yourself bike repair workshops conducted at the two bike hubs provides participants free tools, knowledge, and support needed to repair and maintain their own bicycles, promoting self-sufficiency and sustainable transportation. MC hosted booths at major city events like Markham Cycling Day, Earth Day, and the Children's Festival, offering cycling information and free simple bike repairs to attendees at these events. MC also provides Markham residents with the opportunity to borrow a bicycle, helmet, and lock for up to two weeks using a Markham Public Library membership card. Bikes can be renewed for an additional two weeks, depending on availability, making it a flexible and accessible program for community members.

MC organizes staff and volunteer-led group bike rides that help participants build confidence in cycling and navigating Markham's trails and infrastructure. This activity is popular with families, kids, and youth, offering a safe and supportive environment for all skill levels. Community events include annual themed rides, such as a BBQ Ride and Halloween Ride, fostering community engagement and fun.

Workshops were held in partnership with Markham Public Libraries at different library locations in the City offering bike repair and maintenance, such as fixing a flat tire, basic bike maintenance, winter cycling tips, etc., providing practical cycling knowledge to the community in accessible, familiar spaces. Recycle To Ride bike giveaways events were held in partnership with York Region and Newmarket Cycles to support sustainable transportation initiatives. Bike rescue clinics were held where aspiring volunteer mechanics refurbish donated bikes, gaining hands-on experience. Bikes are picked up from the Richmond Hill and Vaughan waste depots, refurbished and distributed to community members in need through three large-scale bike giveaway events, providing accessible, sustainable transportation options. Immigrant youth in the age group of 12-24 are invited to the Cycle the City Youth Program conducted by MC where each participant gets a bike, helmet, and repair kit to keep, ensuring they have everything needed for safe and independent cycling. Summer Training and Rides runs in two cohorts over four weeks during July and August, featuring weekly training sessions followed by a group ride to build skills and confidence on the road.

MC, in partnership with Cycling Without Age, is preparing volunteers for the 2025 programming, equipping them to operate trishaws safely and confidently. Volunteers joined the annual MC BBQ and Halloween group rides, enhancing the community cycling experience for all participants.

A summary of key metrics for MC in 2024 is shown below:

Kevin Lee provided a brief overview on the activities being planned for 2025. The program has already achieved success with the current budget, demonstrating CICS's ability to accomplish more if additional resources, including funding and staff support were available. With increased staffing and expertise, MC could introduce new initiatives like "Learn to Ride" programs, as well as expand offerings to serve more youth and families, enhancing overall community impact. CICS is applying to various funding agencies, including Canada Summer Jobs, for new funds.

7.9.1 – e-Bikes for Markham Cycles

As discussed in October, there is a particular need for 5 more e-bikes to loan out via the Library. Kevin provided the following breakdown for a Budget Request from CPAC:

The NCM Milano Plus Electric Bike presents the best budget value and fulfills several essential criteria needed for Active Transportation. This bike is designed for daily commuting, making it ideal for Active Transportation. It also aligns with MC's existing e-bike fleet, featuring interchangeable batteries for streamlined maintenance. It is equipped with fenders, a rear rack, and hardwired lights for safety. The bike's step-through frame and 26-inch size ensure accessibility for a wide range of riders, promoting community inclusivity. This bike offers a smoother ride with front suspension and 2-inch-wide tires, ensuring comfort and stability for daily commuters navigating various road conditions.

Keenan Mosdell provided a brief overview and justification for a budget request from CPAC to purchase 5 pedal-assist e-bikes for Markham Cycles.

Moved by: Anthony Ko Seconded by: Doug Wolfe

Whereas, e-bikes are becoming an important component of micromobility and last mile solutions in North America and Markham; and

Whereas, Markham Cycles plays a vital role in encouraging cycling usage in Markham, with thousands of annual participants in numerous programs, including working with Markham Public Library on a bicycle lending library; and

Whereas, Markham Cycles has identified a need to increase its offer of e-bikes to Markham residents via the lending library.

Be it resolved that:

- 1. The City of Markham purchase 5 pedal-assist e-bikes in 2024, at an approximate cost of \$10,000, with specifications and models consistent with Markham Cycles analysis, for donation to Markham Cycles, using funding available from the 2024 approved Capital Project Number 24034 (Cycling and Pedestrian Advisory Committee); and
- 2. That Markham Cycles report back to CPAC annually on the benefits of these new e-bikes.

CARRIED

The Committee discussed liability insurance issues for users of these loaned e-bikes. Kevin Lee, Program Manager-Youth Services, CICS advised that Markham Cycles has a blanket insurance policy cover for users of these e-bikes.

Action: Kevin, Keenan and Fion to expedite purchase of the 5 pedalassist e-bikes before the end of 2024.

7.10 City Budget for AT related items – 2025

Fion Ho, TDM Coordinator, Transportation advised that the proposed 2025 budget was tabled by the Mayor on October 28th. A Public meeting was held on November 4th. A Special Council meeting will be held on November 27th to further discuss the proposed 2025 Budget.

Reena Mistry advised about a presentation she recently attended made to the York Regional Police by a company from Europe on safety reflectors for pedestrians that reflect from 900 to 1300 metres. She volunteered to forward the presentation to Fion. She suggested that CPAC could utilize this as a good use for funding. Peter Miasek, Chair suggested that this could be considered if the purchase can be made before the end of this year. Reena advised that this could be a quick purchase, she met the vendors and could provide the information to Fion soon after this meeting.

That the remaining 2024 budget be utilized to purchase pedestrian reflectors, to be researched by Reena and Fion, failing which the budget be utilized for purchasing bike bells.
