

## Petition Against the Proposed Official Plan and Zoning By-law Amendment (Plan 24 198977)

Dear Mayor, Councilors, DSC and Staff,

We, the residents of the Markham, hereby express our deep concerns regarding the proposed development plan for the lands on the south side of 14th Avenue and the east and west sides of Lepp Drive. While we understand the necessity of urban development, excessive intensification will severely impact the quality of life for existing residents and bring about pressures on public safety, the environment, traffic, and more. Therefore, we are writing to strongly oppose the proposed Official Plan and Zoning By-law Amendment. Based on the following concerns, we respectfully request that you reconsider and reject this proposed amendment:

### Fire Safety Hazards

According to the public notice regarding the land use changes on the south side of 14th Avenue and the east and west sides of Lepp Drive, the plan includes the construction of three apartment buildings with 785 units and 34 townhouses. Assuming an average of 3 residents per apartment, this would add approximately 2,355 new residents. With such a high population density, how can the safe evacuation of over 2,000 people be ensured in the event of a fire or other emergency? Is there a risk of stampedes due to overcrowding? Additionally, the apartment building will be adjacent to existing homes, potentially exacerbating safety hazards for neighboring residents during emergencies.

### Traffic Congestion and Parking Issues

Assuming each household owns one car, the parking of 785 vehicles will pose a significant challenge. Insufficient parking spaces may lead to vehicles being parked haphazardly near intersections, further worsening traffic congestion. Moreover, 14th Avenue and Markham road, as major east-west thoroughfares, already face congestion issues. The influx of new vehicles will lead to more severe traffic gridlock, increased carbon emissions, and environmental pollution.

### Insufficient Community Public Facilities

At present, the community only has the Aaniin Community Centre, which offers limited public facilities, including one indoor sports field, two swimming pools, a small gym, and two outdoor basketball courts. Existing resources are already insufficient to meet residents' needs, with children often facing long waitlists for sports, arts, and other extracurricular programs, and adults struggling to book gym time. The children's library is also cramped, and the addition of more residents will further overcrowd these facilities, significantly reducing the quality of life.

### Strained Educational Resources

Markham Elementary School within the community is already facing a shortage of classrooms and teachers, with junior kindergarten (JK) and elementary classes sometimes being combined. The influx of new residents will place even greater pressure on the already overburdened education system, negatively impacting children's learning environments and the quality of education.

### Inadequate Healthcare Resources

The nearby Markham Stouffville Hospital is already struggling with long wait times and limited services. The addition of new residents will further strain healthcare resources, potentially leading to even longer wait times, reduced access to medical services, and a severe shortage of family doctors. This poses a significant threat to residents' health and well-being.

#### Pressure on Infrastructure

The addition of 785 new households will place direct pressure on the community's electricity, water, and natural gas infrastructure. Without upgrades to the power system, residents may face blackouts or power failures during peak usage times, disrupting daily life.

#### Environmental Protection and Sustainable Development

High-density living will result in a severe shortage of public green spaces and recreational areas, significantly reducing residents' quality of life. Additionally, the increased population may lead to more waste management issues, noise pollution, and other potential environmental hazards, which run counter to the principles of sustainable development.

#### Planning Process Integrity

The application includes OPA for block 270, 271, ZBA for block 270. Although the agenda suggests building C will be submitted under a different cover. The application include references to Building C all over the place.

This blurs procedural clarity, as any approval of site layouts, parking, and servicing could pre-approve conditions for Building C without proper public scrutiny – A violation of Planning and Approval Procedures.

#### Heritage House Protection

On block 271 there is a heritage house next to the proposed Building C. However there is no legally binding Heritage Easement Agreement and impact assessment provided to the public. This creates a situation that changes to the surrounding of heritage house could be pre-approved without proper procedure – A violation of *Ontario Heritage Act*

#### Impact on the Housing Market and Residents' Financial Stability



Housing prices in the community are already high, and with rising interest rates in recent years, many homeowners are already burdened with heavy mortgage payments. The introduction of affordable housing may alter the community's overall image and market expectations, further impacting property values. The potential risk of declining home prices could undermine the exchange value and investment returns of properties, potentially leaving homeowners in financial distress and negatively affecting their long-term financial stability and quality of life.

#### Conclusion

In accordance with the Ontario Planning Act, we hope for more open and transparent community consultation meetings to ensure that residents' voices are heard and that the decision-making process is fair and just. Urban development should prioritize residents' quality of life and the sustainable development of the community, rather than solely focusing on increasing population and building density.
