

By-law 2015-66

A by-law to dedicate certain lands as part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

- 4. That Part of Lot 59, Plan 65M-4364 designated as Part 16, Plan 65R-35007, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
- 4. That Part of Lot 96, Plan 65M-4364 designated as Part 19, Plan 65R-35007, in the City of Markham, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
