



## By-law 2014-57

**To amend By-law 2012-92 being a bylaw to Provide for the Licensing and Regulation of Owners, Operators, and Brokers of Mobile Businesses (Mobile By-law) and to amend By-law 2012-158 being a by-law to Provide for the Licensing and Regulation Stationary Businesses (Stationary By-law)**

Whereas Section 151 of the *Municipal Act, 2001, S.O. 2001.C.25* as amended, provides that a local municipality may license, regulate and govern any business, wholly or partly carried on within the municipality even if the business is being carried on from a location outside the municipality; and,

Whereas administrative amendments are required from time to time for enforcement purposes;

Now therefore the Council of the Corporation of the City of Markham hereby enacts as follows:

(1) That Mobile Licensing Bylaw 2012-92 be amended as follows:

- (A) The definition of "TAXICAB" be deleted in its entirety:  
"means a MOTOR VEHICLE as defined in the *Highway Traffic Act*, other than a car pool VEHICLE, and is equipped with four (4) PASSENGER accessible doors and having a seating capacity of not less than four (4) PASSENGERS and not more than seven (7) PASSENGERS, exclusive of the DRIVER, and that is equipped with a TAXICAB METER and hired for one specific TRIP for the transportation exclusively of one PERSON or group of PERSONS, and or goods for hire or reward, on e FARE or charge only being collected or made for the TRIP."

and replace it with the following definition of "TAXICAB"

*Taxicab* means a motor vehicle as defined in the *Highway Traffic Act*, and includes any Motor Vehicle used for hire in the conveyance of Persons from place to place within the City to any point inside or outside that area, but does not include a limousine.

- (B) That the word "**Town**" be replaced with "**City**" throughout the By-law.
- (C) That any capitalized words be changed to lower case italics throughout the By-law.

2. That Stationary By-law 2012-158 be amended as follows:


- (A) Section 4.1 be deleted in its entirety:  
"The following PERSONS must be in possession of a LICENCE authorizing them to carry on their BUSINESS in the TOWN, and shall pay to the TOWN upon application for, or renewing the LICENCE the required fee."


And replace Section 4.1 with the following:

"The following PERSONS must be in possession of a LICENCE authorizing them to carry on their BUSINESS in the TOWN, and shall pay to the TOWN upon application for, or renewing the LICENCE the required fee."

- (a) every person who owns or operates an Adult Entertainment Parlour (Services);
  - (b) every person who owns or operates an Adult Entertainment Parlour (Goods);
  - (a) every Adult Entertainment Attendant;
  - (b) every person who owns or operates a Place of Amusement (Carnival);
  - (c) every person who owns or operates a Place of Amusement (Arcade);
  - (d) every person who owns or operates an a Personal Services Shop;
  - (e) every person who owns or operates an a Billiards Establishment;
  - (f) every person who owns or operates a Bowling Alley;
  - (g) every person who owns or operates a Body Rub Parlour;
  - (h) every Body Rub Parlour Attendant;
  - (i) every person who owns or operates a Charity Clothing Bin;
  - (j) every person who owns or operates as a Driveway Paving Company;
  - (k) every person who owns or operates a Dry Cleaning Depot;
  - (l) every person who owns or operates an Eating Establishment;
  - (m) every person who owns or operates a place where Foodstuffs are sold;
  - (n) every person who sells Fireworks;
  - (o) every person who owns or operates a Public Garage;
  - (p) every person who owns or operates an Horse Riding Establishment;
  - (q) every person who owns or operates a Public Hall;
  - (r) every person who owns or operates a Salvage Shop or Yard;
  - (s) every person who owns or operates a Second Hand Shop;
  - (t) every person who conducts a Special Sale;
  - (u) every person who installs Mobile Signs;
  - (v) every Temporary Vendor; and
  - (w) every person who sells tobacco.
- (B) That Section 4.2 be amended by replacing "Section 5" with Section "4.1".
- (C) That the word "**Town**" be replaced with "**City**" throughout the By-law.
- (D) That any capitalized words be changed to lower case italics throughout the By-law.
