

By-law 2014-28

A by-law to dedicate certain lands as part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

Whereas Blocks 375 and 377, Plan 65M-3767, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Blocks 43, 44, 45 and 46, Plan 65M-4054, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Part of Lot 14, Concession 9, designated as Parts 1 to 6 inclusive and Part 17, Plan 65R-20360, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Blocks 131 to 141 inclusive, Plan 65M-4375, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

And Whereas Block 227, Blocks 229 to 235 both inclusive, Blocks 237 to 241 both inclusive, Blocks 243, 245 and 246, Plan 65M-4306, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

Now therefore the Council of The Corporation of the City of Markham hereby enacts as follows:

- 1. That Block 375, Plan 65M-3767, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Cornwall Drive.
- 2. That Block 377, Plan 65M-3767, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane K.
- 3. That Block 43, Plan 65M-4054, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane 3.
- 4. That Block 44, Plan 65M-4054, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Bittersweet Street.
- 5. That Block 45, Plan 65M-4054, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Murray Wilson Drive.

- 6. That Block 46, Plan 65M-4054, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane 2.
- 7. That Part of Lot 14, Concession 9, designated as Parts 1 to 6 inclusive and Part 17, Plan 65R-20360, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Almira Avenue.
- 8. That Block 131, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Cornwall Drive.
- 9. That Block 132, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Stone Jug Avenue.
- 10. That Block 133, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Lane.
- 11. That Block 134, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Almira Avenue.
- 12. That Block 135, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Demott Avenue.
- 13. That Blocks 136, 137 and 140, Plan 65M-4375, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named Cornell Centre Boulevard.
- 14. That Block 138, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Church Street.
- 15. That Block 139, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Cinemark Avenue.
- 16. That Block 141, Plan 65M-4375, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named The Meadows Avenue.
- 17. That Block 227, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Donald Sim Avenue.
- 18. That Block 229, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Demott Avenue.
- 19. That Block 230, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Disk Drive.
- 20. That Block 231, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Cornell Park Avenue.

- 21. That Blocks 232, 234, 238, 239, 241, 245 and 246, Plan 65M-4306, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named Lane.
- 22. That Block 233, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Raven Cross Avenue.
- 23. That Block 235, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named The Meadows Avenue.
- 24. That Block 237, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Cinemark Avenue.
- 25. That Block 240, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Frank Davis Street.
- 26. That Block 243, Plan 65M-4306, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named Church Street.
