

## **BY-LAW 2013-162**

A by-law to dedicate certain lands as part of the highways of the City of Markham

The Corporation of the Town of Markham has changed its name to The Corporation of the City of Markham by By-law No. 2012-120 enacted and passed May 29, 2012, effective July 1, 2012, as evidenced in Instrument No. YR1847438 registered June 29, 2012.

WHEREAS Blocks 601 to 613 inclusive and Block 615, Plan 65M-4325, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

AND WHEREAS Block 211, Plan 65M-3245, in the City of Markham, Regional Municipality of York was conveyed to The Corporation of the City of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. THAT Blocks 601, 602 and 615, Plan 65M-4325, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named WILLIAM BERCZY BOULEVARD.
- 2. THAT Block 603, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named CHARLES VOGEL DRIVE.
- 3. THAT Block 604, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named MANILA AVENUE.
- 4. THAT Block 605, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BUSCH AVENUE.
- 5. THAT Block 606, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BECKETT AVENUE.
- 6. THAT Block 607, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BROCK AVENUE.
- 7. THAT Block 608, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HUA DU AVENUE.
- 8. THAT Block 609, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HENRY BAUER AVENUE.

- 9. THAT Block 610, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named WILFRED MURISON AVENUE.
- 10. THAT Block 611, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HUBNER AVENUE.
- 11. THAT Block 612, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HOLST AVENUE.
- 12. THAT Block 613, Plan 65M-4325, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named BRUNSWICK AVENUE.
- 13. THAT Block 211, Plan 65M-3245, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named HARBORD STREET.
