

BY-LAW 2013-163

A by-law to amend By-law No. 2012-137, being a by-law to impose fees or charges for licences and permits issued by the City of Markham

WHEREAS paragraph 391(a) of the Municipal Act, 2001, S.O. 2001, c.25 authorizes municipalities to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM HEREBY ENACTS AS FOLLOWS:

- 1. That the Schedules "A', "B" and "C" of By-law No. 2012-137, being a by-law to impose fees or charges for licences and permits issued by the City of Markham, be deleted and the attached Schedules of this by-law be included.
- 2. That this by-law comes into force and takes effect upon its passage.
- All other provisions of By-law 2012-137, except as herein amended or effected, which are not inconsistent with the provisions of this By-law, shall continue to apply.
