1. Road Closure & Noise By-law Exemption Requests

The Town receives and approves applications for road closures and exemptions to the Noise By-law for community events each year. In 2011, staff approved over 350 applications for community events and over 40 noise exemptions. To review and approve the requests, staff developed consistent practices to follow. The practices are based on applicable regulations/ by-laws, past experiences with the group, comments/ concerns from various agencies and on the location of the event. Since implementing the current approval process and consistent practices, resident complaints with noise and traffic have been avoided.

The current practice is to permit road closures only during the time period that a community event is occurring with multiple day events. The road is reopened over night and closed again for the event on the next day. This ensures unrestricted passage of emergency service vehicles throughout the night and allows for street maintenance operations. Re-opening the road overnight also reduces activity on the street which mitigates noise and parking issues and allows for the surrounding residents to freely access their homes and businesses, outside of the event hours.

Noise exemptions are granted to 11 p.m. only for events adjacent to residential areas. (Exemptions have been granted to midnight at Markham Fairgrounds where there is no adjacent residential area) The 11 p.m. limit has been established based on positive public feedback. The feedback established 11 p.m. as a reasonable compromise to those who live in the immediate area and who would prefer not to hear noise at night.

2. Markham Village Music Village Festival Request

The Markham Village Music Festival has previously followed the standard road closure requirements and noise exemption limit. This year, the Festival is asking for approval to maintain the road closure overnight (Beginning on Friday, June 15th at 3 p.m. and ending on Saturday, June 16th at 6 p.m.) and is asking for the noise exemption to be extended for a further hour to 12 p.m. on Friday night only. The additional road closure will mean that the Festival organizers will not have remove stages, tables, vendor booths etc. from the road and will allow the festival to continue for an extra hour.

Staff Concerns with Overnight Road Closure & Midnight Noise Exemption:

- 1. Town has implemented an 11 p.m. limit on noise exemptions for Main Street, Community Events, and for events at the Civic Centre. The 11 p.m. limit has become an expectation for surrounding residents, some who were originally opposed to any noise exemption. Allowing the exemption will set a precedent for other community groups and similar requests.
- 2. Access on Main Street being blocked by unmanned barriers during the overnight periodimpeding emergency services and access for local residents;
- 3. Vandalism and security concerns with tables etc. enticing persons to remain out on Main Street;
- 4. Noise complaints;
- 5. Parking in adjoining residential areas causing nuisances for residents and noise with persons returning to the vehicles late at night;
- 6. Fire- advises that response time would be impacted two ways: (a) having to pass through barriers (b) travelling down a restricted fire lane on Main Street
- 7. Funeral Home- Any visitations on the Friday end at 4 p.m., the funeral home requested and the Town has established 4 p.m. as the earliest time to block direct access.

Four options have been prepared for Council's consideration.

Option 3	Noise exemption till 11 p.m. and permit overnight road closure as per Option 2.	
Option 4	Permit the Noise Exemption to midnight; however, require the road to be reopened over night
