

## BY-LAW 2012-252

A by-law to amend Fee By-law 2002- 276

WHEREAS Section 391 of the *Municipal Act*, 2001 provides that a municipality may pass a by-law for imposing fees or charges for services or activities provided by or done on behalf of it;
