



## **BY-LAW 2012-193**

A by-law to dedicate certain lands as  
part of the highways of the City of Markham

WHEREAS Blocks 65, 66, 67, 69 and 70, Plan 65M-4216, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

AND WHEREAS Blocks 23, 24 and 25, Plan 65M-4215, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;


WHEREAS Blocks 169 to 173 and Blocks 177 and 178, Plan 65M-4025, in the City of Markham, Regional Municipality of York were conveyed to The Corporation of the City of Markham for public use;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. THAT Block 65, Plan 65M-4216, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named STONEY CREEK DRIVE.
2. THAT Blocks 66 and 69, Plan 65M-4216, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named YEN WAY.
3. THAT Blocks 67 and 70, Plan 65M-4216, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named WILLIAMSON ROAD.
4. THAT Block 23, Plan 65M-4215, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named DESJARDIN DRIVE.
5. THAT Block 24, Plan 65M-4215, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named SEDORE STREET.
6. THAT Block 25, Plan 65M-4215, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named DARREN HILL TRAIL.
7. THAT Blocks 169 and 170, Plan 65M-4025, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named DARREN HILL TRAIL.
8. THAT Blocks 171 and 172, Plan 65M-4025, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named CORNFLOWER STREET.
9. THAT Block 173, Plan 65M-4025, City of Markham, Regional Municipality of York is hereby established and laid out as part of the public highways of the City of Markham and named WILLIAMSON ROAD.

10. THAT Blocks 177 and 178, Plan 65M-4025, City of Markham, Regional Municipality of York are hereby established and laid out as part of the public highways of the City of Markham and named SWAN PARK ROAD.
