



## BY-LAW 2012-186

### TO AMEND TRAFFIC BY-LAW 106-71

---

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE CITY OF MARKHAM THAT BY-LAW NUMBER 106-71 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:

1. That Schedule 19 of Traffic By-law 106-71, pertaining to “Traffic Control Signals”, be amended by adding the following locations:

COLUMN 1

INTERSECTION

South Unionville Avenue at 355 South Unionville Avenue

Enterprise Boulevard and Birchmount Road

Enterprise Boulevard and Rouge Valley Drive

Town Centre Boulevard and Wallis Way

Rodick Road and Yorktech Drive

Middlefield Road and Golden Avenue

Bullock Drive and Laidlaw Boulevard

Bur Oak Avenue at 3201 Bur Oak Avenue

Rodick Road and Riviera Drive

Rodick Road and 14th Avenue

2. That Schedule 12 of Traffic By-law 106-71, pertaining to “Compulsory Stops”, be amended by deleting the following locations:




