

## **BY-LAW 2012-85**

A by-law to change a street name in the Town of Markham from Highway 48 to Markham Road

WHEREAS Section 27(1), of the *Municipal Act*, 2001, S.O. 2001, c.25, as amended, provides that Council of a municipality may pass a by-law in respect of a highway under its jurisdiction;

AND WHEREAS the Council of the Corporation of the Town of Markham at its meeting held on April 17, 2012 approved the changing of the street name for a section of Highway 48, legally described as:

Part of Road Allowance Between Concessions 7 and 8

Part of Lots 16, 17, 18, 19 and 20, Concession 7

Part of Lots 16, 17, 18, 19 and 20, Concession 8

All of 10 Foot Widening and Part of Lot 3, Plan 4160

All of Block 25 (street widening) Plan 65M-3634

All of Block 26 (street widening) Plan 65M-3634

All of Block 27 (street widening) Plan 65M-3634

All of Block 4 (street widening) Plan 65M-3761

All of Block 3 (street widening) Plan 65M-3761,

Town of Markham, Regional Municipality of York, to Markham Road;

AND WHEREAS Notice of Council's intention to pass a by-law to change the name was posted on the Town of Markham website;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. That a section of Highway 48 legally described as:

Part of Road Allowance Between Concessions 7 and 8

Part of Lots 16, 17, 18, 19 and 20, Concession 7

Part of Lots 16, 17, 18, 19 and 20, Concession 8

All of 10 Foot Widening and Part of Lot 3, Plan 4160

All of Block 25 (street widening) Plan 65M-3634

All of Block 26 (street widening) Plan 65M-3634

All of Block 27 (street widening) Plan 65M-3634

All of Block 4 (street widening) Plan 65M-3761

All of Block 3 (street widening) Plan 65M-3761,

Town of Markham, Regional Municipality of York, be changed to Markham Road.

- 2. That the provisions of this by-law shall take effect at such time as a certified copy of same certified under the hand of the Clerk and the seal of the Corporation has been registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).
- 3. That this By-law come into force and effect on January 1, 2013.
