

# **BY-LAW 2012-57**

TO AMEND BY-LAW 2002-94 BEING A BY-LAW TO PROHIBIT AND REGULATE SIGNS AND OTHER ADVERTISING DEVICES AND THE POSTING OF NOTICES ON BUILDINGS OR VACANT LOTS WITHIN THE TOWN OF MARKHAM (SIGN BYLAW)

**WHEREAS** pursuant to Subsection 11(2) of the *Municipal Act*, S.O. 2001, c.25, as amended, authority is given to the municipal council to pass a by-law respecting advertising devices, including signs;

**AND WHEREAS** administrative amendments are required from time to time for enforcement purposes;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM ENACTS AS FOLLOWS:

That the Sign Bylaw 2002-94 be amended as follows:

- 1. That the definition of "Open House Directional Sign" be amended by including the words "not exceeding .25m2" after the words "...after portable sign...".
- 2. That Section 4.3.4 be amended to include the words "save and except portable, mobile and banner signs" after the words "...removal of the sign".
- 3. That Section 4.3.5 be amended to include the words "save and except portable, mobile and banner signs" after the words "...at the time of renewal"
- 4. That the following Section 4.4.3 be deleted in its entirety:

### Section 4.4.3 Application for Permit

The applicant shall file with the Enforcement and Licensing Division of the Clerk's Department an application for a permit for a sign referred to in Section 11, 16 and 17.

And replace it with the following new Section 4.4.3:

#### Section 4.4.3 Application for Permit

The applicant shall apply for a permit with the Enforcement and licensing Division of the Clerk's Department for a sign referred to in Section 11, 16 and 17.

- 5. That Section 4.6.1 (d) be amended by replacing the word ".5m²" with the word ".75m²"
- 6. That Section 4.7.1 be amended by adding two subsections: 4.7.1 (P) a sign on a fence 4.7.1 (Q) a sign that spins or rotates
- 7. That the following Section 11.2(iii) be amended to insert the word "fire hydrant" after the word "...driveway...".

8. That Section 11.2(e) be deleted in its entirety:

## Section 11.2(e)

The sign letters on the sign are only in the colours black and white

And replace it with the following new Section 11.2(e):

## Section 11.2(e)

The sign face must be black or white and the sign letters shall be black or white

9. That this by-law comes into force and takes effect on its passing.
