



BY-LAW 2012-30

TO AMEND SPEED BY-LAW 105-71

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT BY-LAW NUMBER 105-71 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:

1. By adding to the following street to Schedule "A" defining a maximum speed of 40 kilometers per hour:
