EXPLANATORY NOTE

TO BY-LAW 2012-50

A By-law to amend By-law 177-96, as amended.

Mattamy (Robinson Creek) Limited Part of Lot 16, Concession 7 19TM-03008, Phase 5

LANDS AFFECTED

The proposed by-law amendment applies to approximately 0.55 ha (1.36 acres) on the north side of 16th Avenue, west of Roy Rainey Avenue, 19TM-03008.

EXISTING ZONING

The lands subject to this by-law are presently zoned Residential Two- (Holding Two) [R2-419(H2)] under By-law 177-96, as amended by By-law 2010-45.

The applicable conditions for the removal of the Holding Provision have been met to the satisfaction of the Town as follows:

a) The Council of the Town of Markham has approved servicing allocation to the lands that are not dependent upon construction of Regional infrastructure

PURPOSE

The purpose of this By-law is to remove the Holding Zone provision on the subject lands.

EFFECT OF BY-LAW

The effect of this by-law is to remove the Holding Zone provision, to permit the construction of 16 detached dwelling units in accordance with the applicable development standards.

2. All other provisions of By-law 177-96, as amended, not inconsistent with the provisions of this by-law shall continue to apply.
