



## BY-LAW 2012-24

A by-law to change the name of Donald Buttress Boulevard  
and Pope John Paul II Square to:  
Donald Buttress Boulevard West; Pope John Paul II Square;  
and, Donald Buttress Boulevard East

---

WHEREAS Section 47, the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a Council of a municipality may pass a by-law to change the name of a highway;

AND WHEREAS the Council of the Corporation of the Town of Markham at its meeting held on February 14, 2012, approved the renaming of Donald Buttress Boulevard and Pope John Paul II Square to Donald Buttress Boulevard West; Pope John Paul II Square; and, Donald Buttress Boulevard East;

AND WHEREAS Notice of Council's intention to pass a by-law to change the name was posted on the Town of Markham website on the following date:

February 10, 2012

AND WHEREAS no person has claimed that they would be adversely affected by the by-law or has applied to be heard;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

1. That Donald Buttress Boulevard and Pope John Paul II Square in the Town of Markham, Regional Municipality of York, more particularly described in Schedule "A" be changed to Donald Buttress Boulevard West; Pope John Paul II Square; and, Donald Buttress Boulevard East;
2. That the provisions of this by-law shall take effect at such time as a certified copy of same certified under the hand of the Clerk and the seal of the Corporation has been registered in the Land Registry Office for the Land Titles Division of York Region (No. 65).
