



## BY-LAW 2011-199

### TO AMEND PARKING BY-LAW 2005-188

BE IT ENACTED BY THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM THAT PARKING BY-LAW 2005-188 BE AND THE SAME IS HEREBY AMENDED AS FOLLOWS:

1. That Schedule "C" of Parking By-law 2005-188, pertaining to "Prohibited Parking", be amended by adding the following:

Bur Oak Avenue	Both	A point 15 metres north of Morning Dove Drive and a point 20 metres south of Morning Dove Drive	Anytime
Bur Oak Avenue	Both	A point 135 meters north of White's Hill Avenue and White's Hill Avenue	Anytime

2. That Schedule "D" of Parking By-law 2005-188, pertaining to "Parking for a Restricted Period", be amended by adding the following:
