# EA Subcommittee Discussion on Arterial Road Widenings

Peter Miasek addressed the Committee and presented a list of pros with respect to the proposed widenings of Bayview Avenue, Kennedy Road, McCowan Road and 16<sup>th</sup> Avenue. He suggested the CPAC not oppose the widenings and work instead towards getting the best possible Active Transportation infrastructure on these roads as well as on other corridors currently having poor infrastructure.

There was discussion regarding whether the study includes where cars are travelling to, and what the final destination is.

Steve Glassman addressed the Committee and presented a list of cons relative to the arterial road widenings.

There was discussion regarding the importance of regular scheduled shuttle buses that move individuals from their beginning destination to a transit location.

The Committee will discuss follow up actions, if any, on this topic at the next meeting.

## Bike-share Feasibility Study Update

Staff advised that the report is underway, and that they are considering a slightly different approach. Staff are also working with York Region.

#### <u>Update on Trail Related Issues</u>

Staff provided an update on trail related issues including approval of a of bicycle rail for Rouge Valley Trail near 14<sup>th</sup> Avenue, and provided a list of five trail connection projects submitted by CPAC and citizens that is going out for RFP for feasibility study:

- Denby Valley Park to Midred Temple Park
- Gatsby Court to Personna Valley
- Vanessa Road to Quantztown Park
- Maple Valley Park
- Valley View Park

## York Region Update

Shawn Smith, York Region delivered a PowerPoint presentation on various topics:

- York Region received \$3.5 million from the Ontario Municipal Commuter Cycling (OMCC) funding application which is exclusive of the \$990,000 received by the City of Markham
- Training of staff on the new Pedestrian and Cycling Planning and Design Guidelines is underway
- York Region School site design guidelines are complete
- The L2L MUP project in Markham has been awarded for construction
- The flexible bollards pilot on Highway 7 is anticipated to be expanded in 2018 to cover the entire length of the buffered bike lane
- Protected bike lanes on Highway 7 east of Town Centre Blvd. is completed
- A new e-newsletter on cycling has been published
- "Making Tracks" program is underway to train teachers to train students on safe cycling and walking
- Looking to increase school participation during Bike to School week May 28 to June 1 by adding more incentives
- York Region will have a booth at the Toronto Bike Show (March 2 to 4)

# Active Transportation Facilities on Mid-Block Crossing north of Major Mackenzie Drive

Peter Miasek addressed the Committee regarding the proposed option being considered for the crossing north of Major Mackenzie Drive.
