The Cycling and Pedestrian Advisory Committee convened at 7:05 p.m. with David Rawcliffe presiding as Chair.

1. DISCLOSURE OF INTEREST

2. APPROVAL/MODIFICATIONS TO AGENDA

There were no changes to the agenda.

3. REVIEW OF STATUS OF CPAC WORK ITEMS

The CPAC meeting summary will be prepared following each meeting, and will be searchable for topics. It will replace the “Status of CPAC Work Items.”

4. MINUTES OF THE MARKHAM CYCLING & PEDESTRIAN ADVISORY COMMITTEE MEETING HELD ON NOVEMBER 16, 2017

5. BUSINESS ARISING FROM THE LAST MEETING

Pedestrian Charter Update

Staff suggested that the Committee members consider the two options on how to proceed with the Pedestrian Charter: Incorporate CPAC comments and finalize for CPAC endorsement or include finalization of the Pedestrian Charter in the 2018 Active Transportation Master Plan as a deliverable of the Master Plan.

There was discussion regarding whether the Pedestrian Charter should be its own separate document or have an Active Transportation Charter that includes the principles in the pedestrian charter as well as other active transportation modes.

Cycling and Pedestrian Advisory Committee supports developing an Active Transportation Charter encompassing all active transportation modes as part of the 2018 Active Transportation Master Plan; and,

That staff proceed with the consultant work to achieve this.

EA Subcommittee Meeting Update

Peter Miasek advised the Committee that the EA subcommittee met on Tuesday December 12, 2017, and that Steve Glassman will be summarizing the pros and cons discussed relative to the proposed road widening. It was suggested that this item be discussed at the January meeting.

Sidewalk Plan Review

The Committee discussed the possibility of having an approval process that does not require a lot of Council and public input. The Committee recommended that Step 5 of the current proposed process be revised to reduce the need for community consultation, as every sidewalk gap on an arterial or collector road does present a potential safety risk.

Staff advised that they will be presenting a report to the Development Services Committee on a plan to accelerate the sidewalk plan to close the gaps and will require additional funding. Staff will present the revised process and construction plan to CPAC in early 2018.

CPAC Letter on Maintaining Connections following Road Improvement Projects

This item has been deferred to the January meeting.

6. DISCUSSION ITEMS IN PRIORITY ORDER

CPAC Budget Review

Staff advised that the remaining budget be allocated as follows:

The Committee supported the proposed allocations, and suggested that staff ensure that the tent is a sturdy one and that the bicycle racks will keep the bicycles secure.

Bike Repair

Daniel Yeung advised the Committee that he has been in contact with a representative from Condo Corp #789 that have approximately 40 used bicycles that they would like to donate to an under privileged group in Markham. It was noted that the bicycles must be removed at the same time. He indicated that some bikes will require tune-ups, and some will require minor repair. There are some bikes that are beyond repair, but the spare parts could be salvaged. Daniel has contacted Summit Cycle who are willing to arrange bike removal, tune-ups and repairs and storage of the bicycles until end of February. He is suggesting that CPAC provide \$1,600 from their budget to have the bicycles repaired. Approximately 10 bicycles are children's bicycles.

The Committee thanked Daniel for his time in pursuing this and is in support of the project.

That CPAC endorse the Bike Repair program, and subsidize bicycle helmets and bells for children's bicycles up to a maximum of \$500 for 10 children.

2018 CPAC Priorities/Workplan

Staff are suggesting that the Committee members to think about and develop a CPAC priorities/workplan for 2018.

It was suggested that staff send an email to all the Committee members so they can consider this over the holidays and it can be further discussed in the New Year.

Cycling Gaps: Intersections

Staff reviewed the three intersections:

Warden Avenue / Apple Creek – install sharrows through the intersection and MUP through the school property

Main Street Unionville/Unionville Gate – install 4 way sharrows

Castlemore Avenue/Markham Road – bike sharrows (east – west), and implement 3 metre cross ride on west leg

There was discussion regarding whether the 3 metre cross ride at Castlemore Avenue/Markham Road might cause confusion between the pedestrian and cyclists.

That CPAC endorse the proposed staff suggestions for the Cycling Gap Intersections, and be directed to proceed with the pilot projects in 2018.

Intersection Improvements Update

Staff reviewed the Doncaster Avenue & Henderson Avenue. It was noted that cyclists would be diverted to on-boulevard cyclic tracks and cross rides at the intersection. There is also the potential for a road diet on Doncaster Avenue as well as Henderson Avenue to allow for bike lanes approaching the intersection.

Staff reviewed Steelecase Road & John Street preliminary concept design. It was also noted that cyclists would be diverted to on-boulevard cycle tracks and cross rides at the intersection. Steelcase already has a bike lane and John Street will be getting a MUP.

7. INFO ITEM/NEW BUSINESS/ANNOUNCEMENTS

Highway 7 Cycle Track Update

Staff advised that York Region has painted the green path through all intersections.

OMCC Funding Announcement

Staff provided an update relative to the \$990,000 OMCC Funding received and provided some example Markham projects, including the John Street MUP Design, Rouge Valley Trail Phase 4, Lake to Lake branch on the east side of Leslie between Highway 7 and Green Lane, Pavement Marking, and Active Transportation Master Plan.

The Committee suggested that this new funding should be used to enhance cycling infrastructure, not simply allow the municipality to substitute this funding for funding previously planned to come from the tax base.

2018 Meeting Dates

Staff confirmed that the meetings dates for 2018 will remain the third Thursday of each month, no meetings in July and August. It was noted that the meeting requests will be sent out next week.

It was suggested that the December meeting be moved up one week.
